Further Information on UA 204/03 (MDE 13/018/2003, 10 July 2003) and follow-up (MDE 13/023/2003, 17 July 2003) - Fear for safety/ Incommunicado detention/ Risk of torture and ill-treatment New concern: Prisoners of Conscience

Tehran's Chief Prosecutor Said Mortazavi has reportedly told the parents of Reza Ameri Nassab that "they should bear in mind the grave stone for their son." This increases concerns for the safety of the three other detained student activists, Arash Hashemi, Said Razavi Faghih and Mehdi Habibi. Amnesty International considers the four men to be human rights defenders and prisoners of conscience, detained solely for the peaceful expression of their political beliefs.

According to a report on the *Peik-e Iran* internet news website on 29 July, Reza Ameri Nassab's parents requested a meeting with the Chief Prosecutor in order to seek the release of their son. During the course of the meeting, Said Mortazavi allegedly also told Reza Ameri Nassab's parents that the crimes committed by their son, a leader of *Daftar-e Tahkim-e Vahdat*, Organization for the Consolidation of Unity (OCU), were so serious that he could be issued with a death sentence. Reza Ameri Nassab was reportedly one of the key originators of an open letter sent by the OCU to Kofi Annan, Secretary-General of the United Nations, on 7 July. The OCU's letter stated that its purpose was "to enumerate the long list of violations against the Universal Declaration of Human Rights (UDHR) by the Iranian government and [to] ask the UN to look into them".

Reza Ameri Nassab's place of detention is still unknown. Mehdi Habibi has reportedly been transferred to an open section of Tehran's Evin prison. The authorities have failed to grant the two men access to their chosen legal representative Abdolfattah Soltani, founding member of the Association for the Defence of Human Rights. There no further information on the legal status of OCU leader Arash Hashemi, although unconfirmed reports have stated that he was released 48 hours after his arrest. It is not known whether he or any of the others have been charged with specific offences.

Said Razavi-Faghih, also held in Evin prison, has been granted access to a lawyer, and the judiciary has reportedly formally extended his period of detention for one month. Before his arrest, Said Razavi-Faghih repeatedly spoke in public about the prospects for the Iranian student movement and sharply criticized the Iranian government. RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Persian, English, French or your own language:

- calling for the immediate and unconditional release of Reza Ameri Nassab, Mehdi Habibi, Said Razavi Faghiih and possibly Arash Hashemi as prisoners of conscience, detained solely for the peaceful expression of their political beliefs;
- expressing concern at reports that Tehran's Chief Prosecutor, Said Mortazavi, reportedly made comments concerning Reza Ameri Nassab's presumed guilt, in contravention of both Article 37 of the Iranian constitution and international standards for fair trials as laid out in Article 14 of the United Nations International Covenant for Civil and Political Rights (ICCPR), and urging Iran's Disciplinary Court of Judges to urgently examine such claims;
- seeking clarification of the legal status of Reza Ameri Nassab, Mehdi Habibi, Said Razavi Faghiih and Arash Hashemi, and calling on the authorities to confirm the whereabouts of Reza Ameri Nassab and Arash Hashemi;
- seeking assurances that the four men will be humanely treated;
- calling for Reza Ameri Nassab, Mehdi Habibi, Said Razavi Faghiih and Arash Hashemi to be granted immediate access to their lawyer, relatives and any medical treatment they might need;
- reminding the authorities that confessions extracted under duress are prohibited by Iranian law and a violation of Article 7 of the International Covenant on Civil and Political Rights (ICCPR), to which Iran is a state party. It states that "No one shall be subjected to cruel, inhuman or degrading punishment."
- calling for all those found responsible of torture of prisoners to be brought to justice in fair trials.
