#### FORCED EVICTIONS ON A MASS SCALE

# 'It's one of the biggest forced evictions in recent years and a clear violation of human rights in Angola.'

Around 3,000 families were forcibly evicted from their homes in the adjoining neighbourhoods of Iraque and Bagdad in the Kilamba Kiaxi municipality of Angola's capital Luanda. The families' homes were demolished, their possessions destroyed, and they were left without shelter.

THE RESIDENTS STOOD AND WATCHED AS THEIR HOMES WERE BEING DEMOLISHED The demolitions, which took place between 20 and 26 July 2009, were carried out at an unprecedented scale and left Bagdad completely flattened and Iraque partially destroyed. Those still in Iraque endure threats of forced eviction.

Armed police, soldiers and presidential guards arrived in both neighbourhoods at 3am on 20 July and ordered people out of their homes before bulldozers began to demolish the houses. The residents stood and watched as their homes were being demolished. Some of those who tried to stop the demolitions were beaten.

During the demolitions, police harassed and threatened those who refused to leave the area. Some residents built

makeshift shelters from the ruins of their homes, only to have them demolished again. On 25 July, police set fire to the last shelters still standing in Bagdad.

None of those evicted will be rehoused or compensated, according to the Luanda Province Vice-Governor. He claimed that residents of Iraque and Bagdad had occupied the land and built their houses illegally, in an area earmarked for development projects. Private consortium Projecto Camama is expected to build a luxury housing complex on the land.

An estimated 1,000 families have been left homeless as a result of previous forced evictions in Iraque and Bagdad since July 2007. None has received compensation for their losses.
