Four of the detainees, including Daniel Nsanzurwimo and Berchmans, held incommunicado in connection with an attack on a civilian aircraft were released on 17 January.

The other detainees remain in police custody at three different locations in Bujumbura: Bernard Barayegeranije and Nathanael Bisesere at the *Police Spéciale de Roulage* (PSP), Special Haulage Police; Barnabé Barayegeranije, Tite Mpawnimana and "Mama Richard" Niyikundana at the *Police de Sécurité publique* (PSP), Public Security Police; and Simon Nani, Rémégie Ntuyahaga, and Seraphine Nduwimana at the *Police judicaire des parquets* (PJP), Judicial Police Force. Amnesty International is concerned that the detainees remain at risk of torture or cruel, inhuman or degrading treatment. They have been refused access to their families. Human rights groups, who are following the cases, have not been allowed to see them in private.

The PJP *Commissaire Général*, Inspector General, who is presiding a commission established by the State Attorney General to investigate the attack, has said that the detainees are not being ill-treated. However, the investigating commission initially decreed that families and friends of those detained cannot bring food to their relatives to supplement inadequate or non-existent rations. As a result, the detainees have been deprived of food. This measure is reportedly still in force.

A number of people, including those named above, were arrested after a SABENA aircraft was hit by gunfire as it approached Bujumbura airport on 4 December 2000. The government of Burundi has attributed the attack to an armed opposition group, the *Forces nationales de libération* (FNL). The detainees are reportedly accused of collaborating with the FNL and failing to warn the authorities that an attack was planned, although the basis for this accusation is unknown. Among those initially detained was Pancras, a low-level government official (*Chef de secteur*) from Kinyinya, who was released on 17 January, and Nathanael Bisesere. Nathanael Bisesere was initially thought to have "disappeared" following his detention. His relatives were told conflicting stories about his whereabouts by various people in authority before it eventually became clear that he had in fact been taken to the PSR police station.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in French or in your own language (Please check that postal services are operating to Burundi from your country):

- calling for guarantees that all those detained will be protected from torture or cruel, inhuman or degrading treatment;

calling for the detainees to be granted immediate access to humanitarian and human rights organizations, lawyers and members of their families;
calling for the basis of their arrest to be made public, and for the detainees to be released if they are not to be charged with a recognizably criminal offence for which there is substantiating evidence.
