BURUNDISalvator NDAMUHAWENIMANA, aged 14 Juvénal NDAYISENGA, his brother, reappeared and released

New names: Celestin HATUNGIMANA, aged 20
Olivier NSABUKUNGIZA, aged 25

Salvator Ndamuhawenimana is now reported to be held at the *Brigade spéciale de Recherche* (BSR), a gendarmerie special investigation unit, in the capital, Bujumbura. It is not known when he was taken there from Ruziba military position, Rural Bujumbura where he was previously held.

Two men, Celestin Hatungimana and Olivier Nsabukungiza, are now known to have been arrested with Salvator Ndamuhawenimana on 15 June 2001. The three lived in the same compound. They are also being held at the BSR.

Torture and ill-treatment is routine at the BSR and Amnesty International remains concerned for the safety of Salvator Ndamuhawenimana, Celestin Hatungimana and Olivier Nsabukungiza.

All are apparently accused of involvement with an armed opposition group, the Forces nationales pour la libération (FNL), National Liberation Forces. In particular, Celestin Hatungimana and Olivier Nsabukungiza are accused of taking food to the FNL which have bases close to Bujumbura. Salvator Ndamuhawenimana is also reportedly accused of involvement in the murder of a local government official, chef de quartier, in the Kamenge district of Bujumbura, attributed by the government to the FNL. Other sources have accused members of the armed forces of being responsible, alleging that he was killed following a dispute over looted property.

Following their arrest, Celestin Hatungimana and Olivier Nsabukungiza were reportedly held in Muha military camp and the *groupement d'intervention*, a para-military unit in Bujumbura which has no legal power to detain suspects. Both are reported to have been tortured with electric shocks under interrogation. They were transferred to the BSR on 2 July 2001.

Juvénal Ndayisenga, who was arrested on 20 June, when he took food to his brother, was taken to an unknown location following his arrest. He was subsequently found at the *groupement d'intervention* and released after several days. He is reported to have been tortured while he was held there.

FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in French or in your own language (please check that postal services are operating to Burundi from your country):

- calling for the authorities to guarantee the safety and physical well-being of Salvator Ndamuhawenimana, Celestin Hatungimana and Olivier Nsabukungiza and for them to be given immediate access to their families, medical care and to humanitarian and human rights organizations;
- reminding the authorities that Salvator Ndamuhawenimana is aged 14, and therefore particularly vulnerable in detention;

- calling on the authorities to clarify the basis for their arrest and for them to be released if they not to be charged with a recognizably criminal offence for which there is substantiating evidence;
- welcoming the release of Juvénal Ndayisenga but expressing concern at his reported torture at the *groupement d'intervention* in Bujumbura, as well as the reported torture of Celestin Hatungimana and Olivier Nsabukungiza, and asking for these reports to be investigated, and if confirmed, for those responsible to be brought to justice.
