**Further information (1) on EXTRA 01/97 (AFR 21/01/97, 6 January 1997) - Death penalty / Legal concern**

The three men named above who were convicted of murder and sentenced to death on 31 December 1996, 3 and 4 January 1997 respectively are still detained at Moroni prison. They have been denied the right to appeal up until now and the appeal court is currently not functioning.

In September 1996, Youssef Ali was denied his right to appeal and publicly executed after he was sentenced to death.

The UA Network should continue their action as requested in the original previous UA. We believe that more appeals could exert the necessary pressure on the authorities to allow the three men their right to appeal and possibly have their sentences commuted.

**RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in French or in your own language:**

- expressing concern at the death sentences passed on Youssef Hamadi, Said Ali Mohamed and Mohamed Youssef;
- urging that the three men be allowed to exercise their right to appeal to an independent and impartial higher appeal court;
- reiterating Amnesty International's concern at the public execution of Youssef Ali in September 1996 without his being able to exercise his right to appeal;
- explaining Amnesty International's unconditional opposition to the death penalty in all cases and urging that the death sentences, if confirmed by an appeal court, be commuted to a more humane punishment.
