The fifteen above-named men were sentenced to death by a military court on 1 June 1998 and may be executed imminently. It is usual that people sentenced to death in Equatorial Guinea are executed very quickly.

There is no right of appeal against convictions and sentences imposed by military courts. These courts are neither independent nor impartial and use "most summary" procedures, severely curtailing the right to an adequate defence.

The men named above were tried in Malabo, the capital, between 25 and 29 May 1998 and found guilty of treason, terrorism and illegal possession of explosives. In the trial they claimed they had been tortured to extract confessions from them. The court disregarded these claims, however, despite the fact that most of the defendants still showed signs of torture.

They were among a group of 117, mostly from the Bubi ethnic group, tried in connection with attacks on a number of military barracks on Bioko Island. Forty-two of the defendants were acquitted while others received prison terms of up to 30 years'. The attacks, which occurred in January, left four soldiers and three civilians dead.

Amnesty International opposes the death penalty in all cases and without reservation, on the grounds that it is a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment or punishment as proclaimed in the Universal Declaration of Human Rights.

BACKGROUND INFORMATION:

The government claimed that the attacks were carried out by members of the Movimiento para la Autodeterminación de la Isla de Bioko (MAIB), Movement for the self-determination of Bioko Island, a Bubi political party. The military

and police arrested over 500 people, between 21 January and mid-February, some of whom were leading members of the MAIB or their relatives.

At least two men were apparently extrajudicially executed by the security forces in reprisal for the attacks on military barracks and at least four of those arrested died as a result of torture in custody. Some of those arrested were released.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing concern that the fifteen people mentioned above have been sentenced to death;
- calling for the commutation of the death sentences;
- expressing concern that the trial was unfair and the defendants had no right of appeal against their convictions or sentences;
- expressing concern that most of the defendants complained that they had been tortured while in pre-trial detention but their complaints were ignored by the court.
