Florencio Elá Bibang, Felipe Esono Ntumu and Juan Ondo Abaga were tried *in absentia* by a military court in the city of Bata in Equatorial Guinea between 6 and 19 September. They were sentenced to 30 years in prison for their alleged involvement in an attempted coup on 8 October 2004. It appears that Antimo Edú was not tried. The whereabouts of the four men are unconfirmed, and Amnesty International fears for their safety.

Florencio Elá Bibang, a former Lieutenant-Colonel, Felipe Esono Ntumu and Juan Ondo Abaga were part of a group of 70 military officers, former military officers and the relatives of the alleged coup leader, charged with crimes including undermining the security of the state; rebellion; treason and negligence; and attempting to overthrow the government. The prosecution had asked for the three men, and three others, to be sentenced to death, but the court did not impose the death penalty.

Florencio Elá Bibang, Felipe Esono Ntumu and Antimo Edú were reportedly arrested by the Nigerian authorities in April. They were apparently travelling to Benin in order to seek asylum there. According to reports, on 3 July the men were abducted from detention at the Army Intelligence Authority in Lagos, Nigeria, by members of the Equatorial Guinea security services, and taken to Malabo, the capital of Equatorial Guinea. Juan Ondo Abanga was reportedly abducted from Benin by Equatorial Guinea security services personnel.

On 20 September, Equatorial Guinea national radio reported that Florencio Elá Bibang, Felipe Esono Ntumu and Juan Ondo Abaga were not in the country. However, Amnesty International has received information that all four men have been held incommunicado in Black Beach prison in Malabo since being abducted.

According to new information, Florencio Elá Bibang has Hepatitis C, rather than Hepatitis A as previously stated. He may not be receiving the medical treatment that he requires.

## **RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible:**

## To the Equatorial Guinea authorities, in Spanish or your own language:

expressing concern that Florencio Elá Bibang, Felipe Esono Ntumu, Antimo Edú and Juan Ondo Abaga have effectively "disappeared", as their whereabouts are unconfirmed;

- expressing concern that three of the men were tried *in absentia* in contravention of international and national law;
- noting that on 20 September Equatorial Guinea National Radio announced that they were not in the country;
- stating that Amnesty International has information that they have been held incommunicado in Black Beach prison since their abduction from Benin and Nigeria earlier this year;
- calling on the authorities to immediately make public the whereabouts of Florencio Elá Bibang, Felipe Esono Ntumu, Juan Ondo Abaga and Antimo Edú;

- urging the authorities to guarantee that the four men are treated humanely, and are not tortured or ill-treated, and calling on the authorities to grant them immediate access to their relatives, lawyers and all necessary medical care.

### To the Nigerian authorities, in English or your own language:

- expressing concern that Florencio Elá Bibang, Felipe Esono Ntumu, and Antimo Edú have effectively "disappeared" in Equatorial Guinea following their abduction and forcible return from Nigeria in July 2005, at the hands of Equatorial Guinea security personnel;
- calling for an independent and impartial investigation into the abduction from Nigeria of Florencio Elá Bibang, Felipe Esono Ntumu and Antimo Edú, for those responsible to be brought to justice, and for full reparation for the victims.
