## Further Information on UA 359/02 (AFR 27/006/2002, 11 December 2002) <u>Incommunicado</u> detention/Fear of ill-treatment/Health concern

GAMBIA Bisher Al-Rawi (m), Iraqi national (Note corrected spelling) Jamil Al-Banna (m), Jordanian national

Bisher Al-Rawi and Jamil Al-Banna are reported to have been secretly transferred to the US Naval Base at Guantánamo Bay in Cuba in early January 2003.

Both men were detained on arrival in Gambia on 8 November 2002 apparently on suspicion of links with the al-Qa'ida movement. Bisher Al-Rawi's brother and another man, both of whom hold UK nationality, were also detained but were released on or around 5 December. Bisher Al-Rawi and Jamil Al-Banna, who have been held in incommunicado detention since their arrest, have been questioned by US investigators and may have been subjected to intimidation and ill-treatment. Neither man has had access to a lawyer, nor appeared in court to challenge the basis or the legality of their detention.

Both the Gambian and US authorities have refused to confirm the whereabouts of the two men.

### **BACKGROUND INFORMATION**

Conditions of detention in the US Naval Base at Guantánamo Bay are harsh and may amount to cruel, inhuman and degrading treatment. Detainees are held indefinitely without access to the courts, lawyers or relatives. Hundreds of suspected al-Qa'ida members or of the former Taleban authorities in Afghanistan have been detained in Guantánamo Bay for many months. The US government continues to ignore international condemnation of their conditions of detention and their continued detention without trial.

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English or your own language:

- expressing concern at reports that Bisher Al-Rawi and Jamil Al-Banna have been secretly transferred to the US Naval Base at Guantánamo Bay in Cuba, after being detained incommunicado for approximately two months:
- expressing concern that their transfer, if confirmed, has taken place before either man has had any opportunity to question in court the basis of their detention, or even have access to a lawyer;
- demanding that the US and Gambian authorities publicly confirm the whereabouts of the two men;
- requesting clarification on the legal process followed which has allowed for them to be transferred in this manner.
