All the above members of the Forum for the Restoration for Democracy (FORD) have now been charged, under Chapter 63 section 66 (1) and (2) of the Penal Code, of "publishing a false rumour which is likely to cause fear and alarm to the public". They have all been released on bail of Ksh 100,000 (£2,000). These nine (not eight as was previously stated in the original urgent action) held a press conference in Nairobi on Friday 10 January 1992 at which they announced that they had evidence proving that the current administration in Kenya intended to hand over power to the army.

Professor Wangari Maathai, founder of the Green Belt Movement in Kenya, who was arrested on 13 January 1992 at her home in Nairobi was charged on 14 January 1992 and released on bail the same day. Professor Wangari Maathai is currently in Nairobi hospital where she is being treated for chronic rheumatism. Her rheumatism had been exacerbated by her prison conditions, as she had been forced to sleep on a concrete floor at Lang'ata Police Station without a mat or blankets.

Josephat Karanja and Matu Wamae were arrested in Nairobi on 11 January 1992 and charged on 13 January 1992 with the above offence and released on bail later the same day.

James Orengo, a lawyer and former Member of Parliament was also arrested in Nairobi on 13 January 1992. He was charged the following day with the same offence and released on bail.

Virginia Wamboi Otieno gave herself up to the police in Nairobi on 14 January 1992. She was arrested and held over night before being charged the following day and released on bail.

On 15 January 1992 George Njanja, Kimani Wa Nyoike, Wanguhu Ng'ang'a (incorrectly referred to as Wangugu Nganga in the original urgent action) and Abdulkadir. K. Hassan all handed themselves into Nairobi magistrates' court. They were charged by the magistrate, Babu Achieng, with the same offence and released on bail the same day.

The statement read out to journalists at the press conference in Nairobi on Friday 10 January 1992 is believed to have been signed by over 100 FORD members, but the leadership of FORD did not approve of the news conference being held. The accusation was immediately denied by the Kenyan Government who warned opposition leaders against spreading alarm.

## FURTHER RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters:

- expressing concern at the conditions under which Professor Wangari Maathai was held at Lang'ata Police station, particularly given her medical condition;
- expressing concern that if Professor Wangari Maathai and the eight other FORD members are imprisoned for views expressed at a press conference on 10 January 1992 they would be prisoners of conscience, imprisoned in violation of Kenya's obligation to uphold the right to freedom of expression;
- urging that charges against Professor Wangari Maathai and the others be immediately dropped.
