On 22 September 1993 the first seven of the above, who had been arrested on 18 September 1993, were brought to court in Nakuru and given access to their lawyers for the first time. They refused to plead to charges which were made against them of possession of weapons and seditious publications and illegally entering a restricted security zone. They claimed the charges were defective as regulations regarding new restricted security zones had not been published or approved by parliament. They are said to deny the accusations of possession of weapons.

**Susan Wangui** was released on bail, but bail applications by the six others, who are held in poor conditions in Bondeni prison in Nakuru, have not yet been judged. Access to relatives is now allowed.

**John Kinyanjui** was transferred to police custody in Nairobi and released without being charged.

Four of the prisoners - **Francis Mureithi Kanothe, Geoffrey Kuria Kariuki John Njoroge Wamwere and John Kinyanjui** - were reportedly beaten by police. In the court hearing, the magistrate ordered that the first three, who were still held in Nakuru, should be given medical treatment, which had been denied. **Dr Lukas Munyua**, an independent doctor and human rights activist, had been refused access to them and was himself threatened by police.

Two other members of the National Democratic Human Rights Organization

(NDEHURIO), which is headed by Koigi wa Wamwere, have also been arrested. They are **Kariuki Kiboi**, a former Railway Workers Union official, and **Joseph Njoroge**. They were arrested when they went to the police to ask about these prisoners. They are reportedly being held incommunicado without having being brought to court or charged with any offence.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or your own language:**

- calling for an independent investigation into reports that four of those arrested were beaten by police, and were held unlawfully beyond the prescribed period before being taken to court;

- seeking public guarantees and assurances of humane treatment of those still held;

- expressing concern at the additional arrests of Kariuki Kiboi and Joseph Njoroge, who appear to have been arrested solely for inquiring about the prisoners, and calling for their immediate release and assurances of their safety and humane treatment;

- reiterating concern that Koigi wa Wamwere, Mirugi Kariuki and the other prisoners may be prisoners of conscience and stating that Amnesty International will be watching the judicial proceedings very closely in view of the pattern of unfair sedition trials of peaceful government opponents, and doubts about the alleged finding of weapons in their possession.
