Amnesty International remains seriously concerned about the safety of several people, including prominent members of the community, who have been arrested in the town of Kenema in the Eastern Province of Sierra Leone.

They include Brima S. Massaquoi, chairman of Kenema town council, who was first arrested some three weeks ago and held at the Secretariat building in Kenema of the ruling Armed Forces Revolutionary Council (AFRC). He was released on 31 January 1998, together with Brima Kpaka, Dr D.P.B. Momoh and several others, but rearrested on 2 February. He is now held in police custody. Others are also reported to have been rearrested.

According to reports, those detained have been tortured and ill-treated. They were beaten about the head, kicked, had their arms tied tightly behind their heads and have sustained serious injuries as a result. One detainee was described as bleeding profusely from head wounds on his release. An as yet unconfirmed report said that one of the detainees had died as a result of torture.

The arrests in Kenema have occurred in the context of fierce fighting between soldiers, who have been joined by the former armed opposition Revolutionary Front (RUF), on the one hand and a civil defence force composed of traditional hunters, known as *kamajors*, on the other. The *kamajors* support President Ahmad Tejan Kabbah, who came to power in March 1996 after elections but who was ousted by the military coup in the May 1997 which brought the AFRC to power.

Those arrested are apparently suspected of supporting the *kamajors*. No charges have been brought against them.

FURTHER RECOMMENDED ACTION: Because of disruption to communications with Sierra Leone since May 1997, Urgent Action coordinators are asked to organize a limited number of appeals only. A restricted international postal service is operating through neighbouring Guinea, but delays are inevitable. Fax machines operate but sometimes intermittently.

Please send faxes/express/airmail letters in English or your own language:

- expressing serious concern about reports of the rearrest on 2 February 1998 of several members of the community in Kenema, including Brima S. Massaquoi, chairman of Kenema town council, who had been released only two days earlier; requesting details of all those held and clarification of the reasons for their continuing detention;
- calling for their immediate and unconditional release, unless they are to be charged with a recognizably criminal offence;
- expressing serious concern about reports that some of those detained have been tortured or ill-treated while in custody and urging immediate measures to ensure that they are protected from torture and ill-treatment and are humanely treated;
- requesting an immediate investigation into these reports of torture or ill-treatment in order to bring those responsible to justice;
- urging that all those detained be allowed immediate access to a doctor, a lawyer and members of their families.
