SUDANMohamed Mahjoub Mohamed Ali, leading member of the banned Sudan Communist Party

Amnesty International fears that Mohamed Mahjoub Mohamed Ali, who was arrested in the capital Khartoum on 28 December 1998, is at risk of torture or ill-treatment in incommunicado detention.

BACKGROUND INFORMATION

Mohamed Mahjoub Mohamed Ali was arrested the day before an open memorandum was sent to President Omar Hassan al-Bashir, signed by himself and 55 other leading members of the Sudanese opposition. The memorandum requested the restoration of democracy in Sudan, respect for human rights and an end to the civil war. It also called for the establishment of a transitional government of national unity in order to seek a mandate to end the current conflict, and to lead the country towards general elections under regional and international supervision.

The memorandum was issued three days before the enactment of a new law, on 1 January 1999, authorizing political associations, which the government says will offer greater political freedom. Opposition groups, however, view the law as merely a cosmetic gesture which does not grant genuine political freedom and have said that they will not register their parties in accordance with it. On 1 January a rally of several hundred anti-government demonstrators was forcefully broken up by police. The atmosphere in the capital remains politically tense.

Mohamed Mahjoub Mohamed Ali, a leading member of the banned Sudan Communist Party, has been arrested and held in incommunicado detention on several previous occasions as a result of his opposition to the Sudan government.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Arabic, English or your own language:

- seeking assurances that Mohamed Mahjoub Mohamed Ali, who was arrested on 28 December 1998, is not being tortured or ill-treated in incommunicado detention;
- expressing concern that he may be a prisoner of conscience arrested solely because of his opposition to the government;
- urging that he be given immediate and regular access to his family, legal representatives and any necessary medical attention;
- appealing for him to be released if he is not to be charged with a recognizably criminal offence and brought promptly to a fair trial.
