SUDAN Sadiq al-Mahdi, former prime minister

Sadiq al-Mahdi, a former prime minister of Sudan and leader of the opposition Umma party, is still in detention, where he has been since his arrest in Khartoum on 16 May 1995. His arrest was part of a crackdown on opposition members throughout Sudan, and in which dozens of people are believed to remain in detention.

Amnesty Intenational remains concerned that Sadiq al-Mahdi is at risk of torture or ill-treatment while being interrogated and that he may be a prisoner of conscience.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/express and airmail letters either in English, Arabic or in your own language:

- expressing concern at the arrest of Sadiq al-Mahdi, whom Amnesty International believes may be a prisoner of conscience, imprisoned on account of his non-violent opposition to government policies;
- seeking assurances of his physical safety and guarantees that he is not being subjected to torture or ill-treatment;
- urging that he be immediately and unconditionally released unless he is charged with a recognizable criminal offence and brought promptly to a fair trial.
