UA 75/04 <u>Death Threats / Fear for safety</u>

ECUADOR Members of Fundación Pachamama (Pachamama Foundation), a human rights

organization

Amnesty International is concerned for the safety of members of a local human rights organization, Fundación Pachamama (Pachamama Foundation), who have received a series of death threats and intimidatory messages. The threats are believed to be linked to the organization's long-standing support of an indigenous community which opposes plans by a foreign oil company to drill for oil in their territory.

On 12 February, Fundación Pachamama members reportedly received three anonymous threatening phone calls. The first phone call, received in the morning, gave the message: "oil means development for the country. If you oppose it you will bear the consequences" ("el petroleo es el desarrollo del país, si ustedes se oponen, aténganse a las consecuencias"). In the second phone call, made a couple of hours later, the anonymous caller used abusive language. In the third call, a few minutes later, an unknown voice said: "we are going to kill you" ("te vamos a matar").

The death threats appear to be related to *Fundación Pachamama*'s work in support of the Sarayaku indigenous community in the Pastaza region. The Sarayaku community strongly opposes the activities of an Argentine oil company, *Compañía General de Combustibles* (CGC), General Fuel Company, which has been granted a concession by the Ecuadorian state to extract oil in the region.

BACKGROUND INFORMATION

The Sarayaku community appears to have been the object of a campaign of intimidation and defamation as a result of their opposition to the concession given to oil companies to start drilling work in their territory (see UA 59/03 (AI Index AMR 28/005/2003, 28 February 2003) and press statement (AI Index AMR 28/003/2004)).

The Sarayaku community argue that oil extraction in their territory will damage their environment and way of life, which they do not want to abandon. They have proposed alternative, sustainable development in their territory so that their culture will not suffer.

In May 2003, the Inter-American Commission ordered the Ecuadorian state to protect the Sarayaku community after some of their leaders received death threats in February 2003. In December, the Inter-American Commission, part of the Organization of American States (OAS), extended the precautionary measures after members of the Sarayaku community were victims of repeated death threats and were physically and verbally assaulted during a demonstration in the same month. However, in January 2004 Ecuador's Minister of Energy and Mines reportedly responded to the Inter-American Commission's precautionary measures by stating that "the OAS does not give orders here" ("Ia OEA no manda aquí") and said that the Ecuadorian state would respect the agreement with the CGC and continue its plans to allow oil exploitation in the area.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern at the death threats received by members of the staff of Fundación Pachamama;
- calling on the authorities to do everything necessary to ensure the safety of the staff, in accordance with the wishes of the staff themselves;

- calling for a full and independent investigation into the death threats, for the findings to be made public, and for those responsible to be brought to justice;
- express grave concern that the threats and harassment against Fundación Pachamama make it increasingly difficult for the organization to carry out its legitimate work on behalf of indigenous communities.
