Guerrero state peasant activist Marco Antonio Abadicio Mayo was shot and wounded on 21 July, in what appears to have been an attempted political killing.

He was ambushed late at night by a group of men who fired at him, hitting him in the chest and arm. He managed to run some distance before he lost consciousness. He was later treated at the Acapulco General Hospital. Four days after the attack, the police reportedly still had not visited the scene of the crime, near the community of Atoyaquillo, in the municipality of Coyuca de Benítez.

Marco Antonio Abadicio Mayo, a member of the *Organización Campesina Sierra del Sur* (OCSS), Southern Sierra Peasant Organization, has noticed people keeping watch outside his house since 12 January, when he was reportedly stopped by soldiers and police in the nearby community of Pueblo Viejo. They beat and threatened him but finally released him without charge.

OCSS members have frequently suffered gross human rights violations at the hands of the security forces and so-called paramilitary groups in Guerrero state, including "disappearances", torture and killings. In July 1995 17 peasants, many of them OCSS members, were killed by Guerrero state police and government officials in the Aguas Blancas massacre. The armed opposition group *Ejército Popular Revolucionario* (EPR), Revolutionary Popular Army, made its first appearance exactly a year later.

Since then the security forces' presence in the state has increased steadily, as have reports of human rights violations, mainly against indigenous peasants. On 7 June 1998 11 people died in the El Charco massacre, and more than twenty killings of peasant activists in Guerrero were reported in the first three months of 2000 alone. Most recently, two OCSS members were killed in Coyuca de Benítez on 21 April.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- expressing concern at the attempt to kill OCSS member Marco Antonio Abadicio Mayo on 21 July in the community of Atoyaquillo, Coyuca de Benítez, Guerrero state;
- calling on the authorities to guarantee his safety;
- urging the authorities to carry out an immediate, independent and full investigation into the attempt to kill him, to make the results public and to bring those responsible to justice;
- emphasising that the failure to effectively investigate all human rights abuses creates a cycle of impunity and encourages further violations.
