## UA 212/97 Medical concern / Prisoners of conscience 14 July 1997

## MEXICOJuan Zamora González, indigenous peasant leader Marcos Zamora González

Indigenous peasant leader Juan Zamora González, who suffers from advanced diabetes, is reportedly being denied proper medical treatment in custody, including an appropriate supply of insulin. There is serious concern for his well-being.

He and his brother, Marcos Zamora González, were arbitrarily detained on 3 May 1997 in the city of Veracruz, the state of Veracruz. Amnesty International believes both men are prisoners of conscience who should be released immediately and unconditionally.

Juan Zamora Gonzalez is a Chinantec Indian and leader of the *Consejo Indígena de Uxpanapa*, (CIUX), Indigenous Council of Uxpanapa, an organization that campaigns for compensation to be paid to the Chinantec communities displaced by the building of hydroelectric dams in the states of Veracruz and Oaxaca.

The two men were detained by members of the State Judicial Police without arrest warrants and were then held in incommunicado detention for 72 hours. Amnesty International believes that Juan Zamora González has been detained solely for his peaceful work with CIUX. His brother, Marcos Zamora González, was allegedly detained purely for being a relative of Juan Zamora González and for being in the company of his brother at the time of his arrest.

# RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish, English or your own language:

- expressing grave concern over Juan Zamora González's state of health and calling for him to be given immediate access to proper medical care;
- expressing concern that Juan Zamora González has been detained because of his peaceful work as an activist in his indigenous community; and that his brother, Marcos Zamora Gonzalez, was arrested purely on the grounds of his relationship to Juan Zamora González;
- calling for the immediate and unconditional release of both Juan Zamora González and Marcos Zamora González, and for them to be granted appropriate compensation.
