Amnesty International can now confirm that Hassim Escandar was executed with Khairulla Khan and Shorin Khan on 30 April 1993. Anthony Najali's execution has been scheduled for the second week of June 1993. Assidin Itting's appeal for clemency is pending before the Sabah Board of Pardons which is presided over by the Head of State of Sabah.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or your own language:**

- urging that Assidin Itting and Anthony Najali be granted clemency and their death sentences be commuted;

- expressing deep regret that Hassim Escandar, Khairulla Khan and Shorin Khan have been executed.
