- Denial of medical treatment / Deteriorating health conditions

THE MALDIVES Ismail Saadiq, businessman

There is grave concern at the Maldivian authorities continued stance on preventing Ismail Saadiq from seeking access to adequate and necessary medical facilities despite continuing reports of his deteriorating health. He is passing blood in his urine and suffering other medical problems.

Amnesty International has received a copy of a medical report written by two Maldivian doctors who have diagnosed Ismail Saadiq as having: *"urolithiasis with haematuria controlled seizures non-A non-B hepatitis with elevated liver enzymes."*

The report recommends an investigation of the liver pathology biopsy and CT/MRI [specialized imaging] evaluation. It is understood that it is not possible for Ismail Saadiq to receive this treatment in the Maldives. His request to travel to Bangkok, where his wife and two children live, in order to obtain medical attention has been denied.

Ismail Saadiq has not received a trial, and the decision on whether or not he should remain in detention is reportedly solely with the Maldivian President. There is suspicion that his continued detention may be a measure to prevent him standing as, or campaigning in favour of, an alternative candidate during the forthcoming presidential elections (due sometime this year). His troubles with the authorities reportedly began after he supported a candidate who contested the last presidential elections in 1993 and who was subsequently tried for "unconstitutional behaviour".

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in English or your own language:

- expressing concern at the deteriorating health of Ismail Saadiq;
- urging the Government of Maldives to allow him access to adequate and necessary medical facilities without delay;
- expressing concern that he has been detained or under house arrest intermittently without trial for the last 18 months in contravention of international human rights standards, possibly for his peaceful opposition to the government, which would make him a prisoner of conscience.
