Facts and figures Housing and Roma in Italy¹

There are about 150,000 Roma, Sinti and Caminanti in Italy, representing around 0.25 per cent of the population of the country. These communities include Italian citizens (about 50 per cent), people from other European Union countries and from the former Yugoslavia, and stateless people. Only about 3 per cent of them are itinerant. More than a quarter of them (40,000) live in camps, either informal or built by the authorities, and are at risk of forced evictions. In Rome and Milan, over 1,000 evictions were reported in the past 6 years. An absolute majority of them were forced evictions.

Number of persons living in Ater social housing dwellings: 104.548 of which foreigners (EU and non EU): 3.591 (3.43%)




Ratio Social rental housing on total housing stock




