Sinan Tanr\_kulu and F\_rat Anl\_, Hanifi I\_k, \_erif Atmaca, and Servet Ayhan, all members of the Diyarbak\_r branch of the Turkish Human Rights Association (HRA), who were detained on 27 February 1995, were brought before a magistrate at Diyarbak\_r State Security Court on 9 March 1995 and committed to Diyarbakir E-type prison to await trial. Amnesty International considers them to be prisoners of conscience, in custody because of their activities on behalf of the HRA.

- appealing for the immediate and unconditional release of Sinan Tanr\_kulu, F\_rat Anl\_, Hanifi I\_k, \_erif Atmaca, and Servet Ayhan, currently held at Diyarbak\_r E-type prison, who are considered by Amnesty International to be prisoners of conscience, detained because of their work for the Turkish Human Rights Association;
- expressing regret at the continued imprisonment of the Turkish Human Rights Association officials Melike Alp, Mahmut \_akar, Nimetullah Gündüz, and Abdullah Ça\_er who are also remanded in custody in Diyarbak\_r.
