On 19 June 1995, the president of the Hakkari branch of the Turkish Human Rights Association (HRA), Abdulkerim, Demirer was detained at his home. He is married with three children. His daughter reported to Amnesty International that police came at 3pm and surrounded the house. Two plainclothes policemen searched the house for an hour. They confiscated several of Abdulkerim Demirel's books and took him to Hakkari Police Headquarters.

Hüseyin Ümit and ükrü Çall , detained on 15 June, are still in custody.

Hakkari is under emergency legislation. Under the Turkish Criminal Procedure Code detainees in this area may be held incommunicado for up to 30 days without access in person or by telephone to their lawyer, family, or a medical practitioner of their choice. Amnesty International believes that Abdulkerim Demirer, Hüseyin Ümit and _ükrü Çall_ may be prisoners of conscience, and that they may be at risk of ill-treatment or torture.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- urging that Abdulkerim Demirer, Hüseyin Umut and _ükrü Çall_ be immediately released or brought before a judge;
- seeking assurances that they are not being subjected to any form of ill-treatment.
- reiterating concern at the continuing detention of members of the Human Rights Association, and calling for them to be allowed to carry out their internationally recognized right to the peaceful defence of human rights without fear of intimidation or arrest.
