The six young people named above were detained around the same time as Süleyman Seyhan, 30 October, and reportedly were seen with him in detention at Dargeçit Gendarmerie Battalion Headquarters. All have allegedly been subjected to severe beating. Their detention has also not been acknowledged by the authorities.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in English or in your own language:

expressing grave concern for the safety of 58-year-old Süleyman Seyhan and of the juveniles Nedim Akkoyun, Davut Alt_nkaynak, Seyhan Do_an, Abdurrahman Olcay, Abdurrahman Co_kun and Mehmet Emin Aslan, all held in unacknowledged detention, reportedly at Dargeçit Gendarmerie Battalion Headquarters;
urging that their whereabouts be establishes without further delay and that their families be informed accordingly;

- requesting to be informed of the result of the investigation;

- seeking assurances that they are not subjected to torture or any other form of ill-treatment.
