UKRAINE: Viktor Petrovich GOROKHOV, farm worker

Amnesty International has learned from unofficial sources that the President of Ukraine has turned down the petition for clemency lodged by a man on death row, Viktor Gorokhov, and that the sentence may be carried out within the next six days.

Viktor Gorokhov, a young farm worker from southern Ukraine, is said to have killed his parents-in-law because he believed them responsible for persuading his estranged wife to refuse him access to their small daughter. He was found guilty of premeditated, aggravated murder (Article 93 of the Ukrainian Criminal Code) and sentenced to death by Nikolayev Regional Court. He reportedly gave himself up after the murders, and was subsequently admitted to a psychiatric hospital for treatment. He is said to have no previous convictions.

Amnesty International opposes the death penalty in all cases and without reservation, on the grounds that it is a violation of the right to life and the right not to be subjected to cruel, inhuman and degrading treatment or punishment as proclaimed in the Universal Declaration of Human Rights. The organization is appealing to the President of Ukraine, Leonid Makarovich Kravchuk, to reverse his decision and commute the death sentence passed on Viktor Gorokhov.

RECOMMENDED ACTION: Please send IMMEDIATELY telegrams/faxes/express and airmail letters either in English or your own language (or Ukrainian if this is possible without delay):

- urging President Kravchuk to reconsider his decision not to grant clemency to Viktor Petrovich Gorokhov, and to commute the death sentence;
- urging President Kravchuk to commute all other death sentences that come before him, in the spirit of Ukraine's co-sponsorship of the Second Optional Protocol to the International Covenant on Civil and Political Rights, the first worldwide treaty aimed at abolition of the death penalty.
