Anvar Gulusoy: opposition politician allegedly beaten by police at post-election demonstration

Anvar Gulusoy is a member of the opposition Musavat Party. He took part at a post-election demonstration in the town of Sheki on 18 November 2000 raising mainly economical and social concerns. Reportedly, he was beaten by the police and sustained a broken arm as a result. It is said that he couldn't use his arm for weeks after the incident. The police reportedly brought him to the investigation-isolation prison at Ganja where he is still kept.
