Egypt:Dr Mohammed MANDOUR
Dr 'Emad 'ATREES

Amnesty International has learned that Dr Mohammed Mandour was released on 23 February 1991. He had been arrested in the early hours of 8 February, and was held first at the State Security Intelligence Police Directorate (SSIP) in Lazoghly, Cairo, then at Abu Za'bal Prison. While held by the SSIP he was reportedly stripped and subjected to suspension, beating and electric shocks.

Following his release, Amnesty International has received the following message of thanks from Dr Mandour:

"Dear Friends and Colleagues,

I would like to express my deep gratitude for your efforts which resulted in my release Saturday evening February 23 1991, by decision of the Minister of the Interior, annulling the administrative order against me.

I should like to inform you that I was released without having had any formal charges made against me, nor was I questioned, throughout my two weeks of detention, by prosecution officials.

I would also like to relate to you the effect your efforts had upon my morale when I learned of them upon my transfer to Abu Zaabal Prison and my meeting with Egyptian Organization for Human Rights lawyers. I felt that I was no longer alone, and the weight of insults, humiliation and physical abuse I had suffered, became much lighter.

It is difficult to find appropriate words to express my gratitude. Your efforts have strengthened my faith in our common movement for human rights, and have increased my confidence that our efforts are worthwhile.

Now that I, myself, have passed through this bitter experience, I pledge to redouble my efforts in the struggle for human rights, and to stand against any violation of human body and of the human dignity."

No further action is required on his behalf.

However, Dr 'Emad 'Atrees remains in prison at Abu Za'bal Prison, following his detention also on Friday 8 February. Please continue appeals on his behalf.

## FURTHER RECOMMENDED ACTION: Telexes/faxes/express and airmail letters:

- welcoming Dr Mandour's release but expressing continued concern at the detention of Dr 'Emad 'Atrees, and seeking assurances that he is being humanely treated;
- urging his immediate and unconditional release unless he is to be charged with a recognizably criminal offence.
