IRAN Hengameh Amini (f), aged 41

Amnesty International has received confirmation that Hengameh Amini was released from prison on 7 November 1994. Her mother is the well-known singer Marzieh, and she had apparently been arrested in connection with her mother's decision to join the opposition group, the National Council of Resistance of Iran.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes and airmail letters

- welcoming the news that Hengameh Amini has been released from prison;
- seeking assurances that her release is unconditional.
