Brothers Karim and Kamran Latif have been released, reportedly on bail. They are said to have been forced to sign an undertaking to give up all political activities, and relinquish their membership of the Iraqi Workers' Communist Party (IWCP).

Sadiq Nikbin is said to have been moved to a prison controlled by the PUK security and intelligence service, *Dezgay Zanyari*. He may still face forcible return to Iran.

A Palestinian, 'Isam Samir 'Awda, has been held since 24 July, reportedly because his brother is an IWCP member.

PUK security forces are said to have arrested nine more IWCP members, named above, between 24 and 26 August. Their whereabouts are now unknown.

There is still no information about the fate and whereabouts of Kuchar, Nidhal Ahmad, Shazin Heersh, the 12 women who were sheltering in a women's refuge in Sulaimaniya, as well as all those who were arrested on 21 July and 10 August.

The PUK offices in Germany and the UK have replied to Urgent Action network appeal writers. They say that for security reasons the authorities in Sulaimaniya asked all political parties to vacate their offices and move to other areas. All parties agreed except the IWCP. The PUK confirmed that their security forces had shot dead five people in a car, claiming the car had failed to stop at a check-point. They claim the five opened fire, injuring two people, and were shot dead when the security forces returned fire. An investigation has apparently been launched. In their letters the PUK listed 16 IWCP members they said had never been arrested. Among them were eight people who have appeared

in this UA: Kawa 'Abdullah, Amanj 'Othman, Yusuf Mohammad, 'Ammar Sharif, Taha Baha al-Din, Tahar Hassan, Saman Karim and Fu'ad Sadiq.

The PUK's responses do not address a number of Amnesty International's concerns. They give no information about the fate of Nidhal Ahmad, Kuchar, Shazin Heersh, any of the IWCP members reportedly arrested on 21 July, 9 and 10 August, or the 12 women said to have been forced out of the women's refuge on 21 July. They say nothing about the Iranian nationals, Arsh Baqri and Sadiq Nikbin, who were facing forcible return to Iran.

Amnesty International has so far received no reply to a letter sent to the PUK leader on 26 July.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Arabic, Kurdish or your own language:

- asking why 'Isam Samir 'Awda was arrested on 24 July, and why nine IWCP members were arrested between 24 and 26 August;
- urging that they be immediately released if they were arrested solely because they are IWCP members, or related to IWCP members;
- expressing concern that in their responses to Urgent Action appeals the PUK authorities said nothing about Nidhal Ahmad, Kuchar, Shazin Heersh, Sadiq Nikbin, Arsh Baqri, the 12 women or those IWCP members said to have been arrested since 13 July.
