On 4 December 1991 it was announced that the death sentences passed by the State Security Court on six of the prisoners named above have been commuted to life imprisonment by King Hussein bin Talal. The two men sentenced to death *in absentia* will have the opportunity of a retrial if arrested, according to Article 254 of the Code of Criminal Procedure.

All the defendants were accused of belonging to an organization called *Jaysh Muhammad* (the Army of the Prophet Muhammad) and were convicted on charges including possession of explosives and automatic weapons, attempted murder, acts of terrorism and membership of an illegal violent organization.

Amnesty International welcomes the commutation of the death sentences. It is still calling for all defendants in this case to be granted a fair trial, specifically the right to appeal to a higher tribunal.

FURTHER RECOMMENDED ACTION: Airmail letters

- welcoming the commutation of the six death sentences;
- stressing that AI recognizes that governments are entitled to bring to justice people accused of violent offences, but opposes torture, unfair trials and the death penalty as a matter of principle;
- calling for all 20 defendants to be given the right to appeal to a higher tribunal against their conviction and sentence as laid out in Article 14 of the International Covenant on Civil and Political Rights.
