Raif Badawi, founder of Saudi Arabian Liberals, a website for political and social debate, has been in prison since 17 June 2012 in Briman, Jeddah. He continues to face court hearings marred by irregularities on charges of “setting up a website that undermines public security” and ridiculing Islamic religious figures.

The charges relate to articles he has written, including one about Valentine’s Day (the celebration of which is banned in Saudi Arabia) for which he was accused of ridiculing the country’s Commission on the Promotion of Virtue and Prevention of Vice.

I urge you to drop all charges against Raif Badawi and to release him immediately and unconditionally as he is a prisoner of conscience detained solely for the peaceful exercise of his right to freedom of expression.
