Two of the seven people held in incommunicado detention since their return to Syria from exile in Iraq in April 2003 have been released. Amnesty International has learned that Mayyadah Muhammad Ghassan Benqasli was freed in the early morning of 17 July, and that Fathiyyah Rajab Damur was released in May. It is not known whether they were tortured or ill-treated while in detention.

However, there remain serious concerns for the safety of the other five members of the group, who were all arrested between 18 and 24 April. They are reportedly still being held incommunicado and without being charged with any offence, at an unknown location. They are at risk of torture or ill-treatment, particularly because of their purported links to the outlawed Muslim Brotherhood Organisation.

## RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, French, Arabic or your own language:

- welcoming the releases of Fathiyyah Rajab Damur and Mayyadah Muhammad Ghassan Bengasli;
- expressing concern for the safety of the other five Syrians who are being detained incommunicado at an unknown location following their return from exile in Iraq: Jamal Mahmud al-Wafa'i, Fayzah 'Ali Shihab, Maha Ahmad Qarah Qash, Muhammad 'Adnan Ahmad Madlaj, and Muhammad Ahmad Qashush.
- calling for their immediate release unless they are to be charged with a recognizably criminal offence;
- urging that they be treated humanely and not subjected to torture or ill-treatment in detention;
- calling on the authorities to disclose their whereabouts immediately and allow them immediate and unrestricted access to relatives, lawyers and any medical treatment they require;
- calling for Syria to open its borders immediately to all refugees and asylum seekers from Iraq, without discrimination.
