ALGERIA: Nadir HAMMOUDI

Nadir Hammoudi was brought before the investigating judge on 7 November 1992, and was then allowed to receive visits from his family and lawyer. He had been arrested on 9 October and held incommunicado in garde à vue detention for 29 days, that is 17 days beyond the maximum period allowed by Algerian law under a new anti-terrorist legislation passed in September 1992. Amnesty International has received allegations that Nadir Hammoudi was ill-treated and tortured during incommunicado detention.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in French or your own language:

- expressing concern that Nadir Hammoudi was held incommunicado in prolonged  $garde\ \hat{a}\ vue$  detention for 29 days in breach of Algerian law, which under new regulations provides for a maximum period of 12 days  $garde\ \hat{a}\ vue$  detention;
- expressing concern at reports that Nadir Hammoudi was ill-treated and tortured during  $garde\ \hat{a}\ vue$  detention, and urging the Algerian authorities to set up a full and independent investigation into these allegations, and make its findings public.
