Amnesty International is concerned for the health of Abdel Moumen Belanes, who has been on hunger strike since 17 March 1997 to protest at his detention on charges which he denies and at poor conditions of detention.

Abdel Moumen Belanes' trial, originally scheduled for yesterday, 25 March, was postponed to 1 April at the request of his defence lawyers, who have not yet been able to obtain all the documents mentioned by the prosecution in the charge sheet.

Amnesty International believes that Abdel Moumen Belanes, who was previously detained as a prisoner of conscience and tortured at the end of 1995, is again being detained as a prisoner of conscience and should be immediately and unconditionally released.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French, Arabic, English or in your own language:

- continuing to call for the immediate and unconditional release of Abdel Moumen Belanes as a prisoner of conscience;
- expressing concern for the health of Abdel Moumen Belanes, who is on hunger strike, reiterating concern that he was threatened with torture during secret detention, and urging that he not be subjected to ill-treatment during his continuing detention;
- calling on the authorities to ensure that his trial on 1 April be held in full compliance with international standards for fair trial.
