



POLOGNE. ÉROSION DES DROITS HUMAINS ET DE L'ÉTAT DE DROIT

AMNESTY INTERNATIONAL. COMMUNICATION POUR LA 41^E SESSION DU GROUPE DE TRAVAIL SUR L'EPU, NOVEMBRE 2022 (ANNEXES EN ANGLAIS)

RÉSUMÉ

La présente communication a été préparée en vue du prochain Examen périodique universel (EPU) de la Pologne, qui doit se tenir en novembre 2022. Amnesty International y évalue la mise en œuvre des recommandations adressées à la Pologne au cours de son EPU précédent, concernant notamment la liberté de réunion pacifique, la législation en matière d'asile, les droits des enfants, les droits des personnes LGBTI, les droits des femmes et l'état de droit.

L'organisation examine également le cadre national des droits humains concernant les obligations internationales de la Pologne, l'indépendance de la justice et l'Institution nationale des droits humains (INDH).

En ce qui concerne la situation des droits humains sur le terrain, Amnesty International exprime ses préoccupations concernant la discrimination, le droit d'asile, les droits des femmes, les droits sexuels et reproductifs, de liberté de réunion pacifique et de liberté d'expression.

Le document se termine par une série de recommandations à l'intention de la Pologne qui, si elles étaient mises en œuvre, contribueraient à améliorer la situation des droits humains.



LE PRÉCÉDENT EXAMEN ET SES SUITES

1. La Pologne a accueilli favorablement 144 des 185 recommandations¹. Des progrès ont été faits concernant les droits des personnes en situation de handicap, avec notamment l'élaboration d'une nouvelle stratégie à leur intention et à celle de leurs aidants pour 2021-2030 qui est axée sur l'indépendance financière et l'inclusion scolaire.
2. La Pologne a pris note de recommandations essentielles concernant la protection des droits humains, notamment sur le droit de réunion pacifique, la participation au programme de relocalisation des réfugiés, le droit d'asile, les droits des enfants, la reconnaissance des unions civiles entre personnes de même sexe et la séparation des fonctions entre le ministère de la Justice et le parquet². Ces recommandations portent sur des problèmes brûlants en Pologne : la discrimination des personnes LGBTI³, les restrictions de la liberté de réunion pacifique, les coups portés à l'indépendance de la justice⁴ et les violations des droits des migrant·e·s et des réfugié·e·s.

CADRE NATIONAL DE PROTECTION DES DROITS HUMAINS

3. La Pologne n'a toujours pas ratifié la Convention internationale pour la protection de toutes les personnes contre les disparitions forcées⁵. Les autorités ont annoncé leur intention de se retirer de la Convention du Conseil de l'Europe sur la prévention et la lutte contre la violence à l'égard des femmes et la violence domestique (Convention d'Istanbul)⁶.
4. La Pologne n'a pas mis en œuvre les 16 recommandations acceptées⁷ concernant l'indépendance de la justice, et notamment celle de la Cour constitutionnelle. Le gouvernement a continué d'exercer un contrôle politique sur la justice, notamment sur les juridictions de droit commun, le Conseil national de la magistrature et la Cour suprême.
5. Le médiateur a joué le rôle d'Institution nationale des droits humains (NHRI), dans le respect des Principes de Paris, et a été considéré comme un acteur important de la protection des droits humains dans le pays. Il est actuellement doté d'un statut A d'après l'organe de supervision. Cependant, l'indépendance du médiateur a subi des attaques systématiques : coupes annuelles dans le budget de son bureau ; attaques verbales régulières de la part de représentants de l'État ; et procès intenté contre lui par une chaîne de télévision publique en raison de ses déclarations légitimes (classé sans suite par le tribunal)⁸.
6. À la demande du parti au pouvoir, la Cour constitutionnelle a rejeté une disposition permettant au médiateur actuel de continuer à exercer ses fonctions après la fin de son mandat en attendant que son successeur soit élu. Les candidat·e·s au poste ont été rejettés cinq fois, ce qui compromet la protection des droits humains en Pologne. Le nouveau médiateur a finalement été élu au bout de neuf mois⁹.

Indépendance de la justice

7. La modification apportée en juillet 2017 à la Loi relative aux tribunaux communs donnait au ministre de la Justice le pouvoir de nommer et de démettre les présidents et les vice-présidents de ces tribunaux¹⁰. En décembre 2017, le Parlement a fait passer l'âge de la retraite des juges de la Cour suprême de 70 à 65 ans, ce qui avait pour but de mettre fin aux mandats d'un grand nombre d'entre eux et de permettre la sélection de nouveaux juges pour les remplacer¹¹. En janvier 2018, le Parlement a adopté un nouveau règlement sur la composition du Conseil national de la magistrature, qui a débouché sur l'interruption forcée du mandat de quatre ans du bureau et a politisé l'élection de nouveaux membres de cette institution¹².

8. La chambre disciplinaire de la Cour suprême, créée en 2018, comprend des membres élus par le Conseil national de la magistrature, qui est politisé. En décembre 2019, une modification de la loi qui étend et renforce les responsabilités disciplinaires des juges a été adoptée¹³. Le régime disciplinaire modifié a été utilisé pour sanctionner les juges qui critiquent les réformes du système judiciaire. La chambre disciplinaire continue d'agir malgré plusieurs avertissements de la Commission européenne, de mesures provisoires et de pénalités financières pour non-respect des décisions de la Cour de justice de l'Union européenne (CJEU)¹⁴.
9. Les autorités polonaises continuent de renvoyer des affaires devant la Cour constitutionnelle, soumise à l'influence du pouvoir politique, pour contester les décisions de la CJEU et de la CEDH et empêcher ainsi leur application dans le pays. En octobre 2021, la Cour constitutionnelle a estimé que la législation polonaise prévalait sur la législation européenne et que certaines dispositions du Traité sur l'UE étaient inconstitutionnelles.
10. Les fonctions du ministre de la Justice et du parquet ne sont pas séparées. Le parquet est toujours soumis à l'influence du pouvoir politique, ce qui explique que les procureurs qui défendent l'état de droit aient subi des représailles simplement pour avoir fait leur travail. Certains ont reçu un préavis de 48 heures leur enjoignant de prendre un nouveau poste, parfois à des centaines de kilomètres¹⁵.

SITUATION EN MATIÈRE DE DROITS HUMAINS SUR LE TERRAIN

Discrimination

11. La Pologne a accepté six des recommandations relatives à la modification du Code pénal visant à enquêter sur les crimes motivés par la haine sur la base de l'âge, du handicap, de l'orientation sexuelle et de l'identité de genre et à poursuivre ces agissements, mais n'a rien fait en ce sens. De même, aucune mesure nécessaire visant à lutter contre la discrimination fondée sur la race, le sexe, la nationalité, l'ethnicité et la religion n'a été prise¹⁶.
12. Pourtant, la situation des personnes LGBTI en Pologne s'est considérablement aggravée depuis le dernier examen. Une campagne électorale du gouvernement ciblant les personnes LGBTI a entraîné une augmentation incontestable de l'homophobie, de la transphobie et de la biphobie¹⁷, notamment avec l'introduction de « zones sans idéologie LGBT » dans des zones de gouvernement local (au nombre de 94 en juin 2020)¹⁸, de campagnes répétées de diffamation, de harcèlement, de profilage et de surveillance des défenseur·e·s des droits humains des personnes LGBTI¹⁹.
13. Depuis 2019, le Code des infractions mineures est de plus en plus instrumentalisé par les autorités pour cibler et sanctionner les gens et notamment les militant·e·s LGBTI, en limitant leurs possibilités de participer à la vie et aux événements publics.
14. Le 20 juillet 2019, Amnesty International Pologne a recueilli des informations sur l'inadaptation de la protection policière apportée aux 1000 participant·e·s à la Marche pour l'égalité à Białystok, violemment agressés par 4000 contre-manifestants qui leur ont lancé des pétards et des pavés²⁰. Deux des agresseurs les plus violents ont été inculpés pour coups et blessures et condamnés à une peine d'un an de prison et une amende, assortie de trois ans de mise à l'épreuve.
15. L'accès à l'éducation aux droits humains et à l'éducation sexuelle est en danger. En mars 2022, le président polonais a opposé son veto à une proposition de modification de la législation sur l'éducation qui cherchait à bannir des écoles les ONG (comme Amnesty International) considérées comme hostiles au programme de sape des droits humains par le parti au pouvoir. Cet amendement est encore à l'examen²¹.

Droit d'asile

16. Depuis 2015, des informations nous parviennent régulièrement qui font état de renvois forcés illégaux (push-back) de demandeurs et demandeuses d'asile aux frontières, principalement à Terespol. En 2017, le Comité des droits de l'homme des Nations unies et la CEDH ont été informés de cas où les gardes-frontières ne permettaient pas aux demandeurs d'asile de soumettre un dossier de demande d'asile, et que ceux-ci se voyaient régulièrement refuser le droit d'entrée pour rechercher une protection internationale, ce qui viole l'obligation internationale de « non-refoulement »²².
17. En août 2021, la crise à la frontière polono-bélarusienne s'est aggravée, avec 32 demandeurs d'asile afghans refoulés au Bélarus par les gardes-frontières polonais²³. En dépit de deux mesures provisoires décidées par la CEDH, la Pologne ne leur a fourni ni nourriture, ni eau, ni abri, ni assistance médicale ni possibilité de consulter un avocat²⁴.
18. Des milliers de demandeurs et demandeuses d'asile et de migrant·e·s ont essayé de franchir la frontière entre le Bélarus et la Pologne à partir d'août 2021, à la suite des actions coordonnées du Bélarus visant à amener des gens à la frontière et à les forcer à la passer²⁵.
19. Les autorités polonaises ont fermé les frontières aux personnes essayant d'entrer dans le pays et leur ont ordonné de quitter immédiatement le territoire²⁶. En octobre 2021, le Parlement a adopté plusieurs modifications de la Loi relative aux étrangers et de la Loi relative à l'octroi d'une protection aux personnes étrangères. En vertu de ces modifications, les personnes qui passent la frontière « de manière irrégulière » doivent quitter le territoire polonais et « ne peuvent plus y revenir »²⁷, ce qui empêche les personnes étant entrées illégalement de demander l'asile en Pologne.
20. Le 2 septembre 2021, le président de la République a déclaré l'état d'urgence à la frontière avec le Bélarus, interdisant ainsi aux journalistes, aux médias et aux ONG d'accéder à la zone frontalière²⁸. La modification apportée en novembre 2021 à la Loi relative à la protection des frontières a donné au ministre de l'Intérieur le pouvoir d'interdire l'entrée dans la zone frontalière sans limitation de durée, ce qui empêche tout suivi et toute activité d'information²⁹. Le nombre de personnes se trouvant dans des centres de rétention fermés a considérablement augmenté, et on trouve parmi elles des familles avec enfants³⁰.

Droits des femmes

21. Bien que la Pologne ait accueilli favorablement dix recommandations³¹ sur la violence familiale ou sexiste, dont deux recommandations³² sur la mise en œuvre de la Convention d'Istanbul, le gouvernement a annoncé prendre les premières mesures permettant de se retirer de cette Convention³³.
22. Le 30 juillet 2020, le Premier ministre a demandé à la Cour constitutionnelle de vérifier la conformité de la Convention d'Istanbul avec la Constitution polonaise³⁴. Le 20 août 2020, le parquet a soutenu ce retrait³⁵. Les deux processus sont en cours.
23. Comme la définition légale de la violence familiale n'englobe toujours pas la violence économique, les initiatives systémiques visant à prévenir et à sanctionner la violence familiale ne s'attaquent pas à ce problème. Ce phénomène n'était pas non plus inclus dans le Programme national pour la prévention de la violence familiale 2014-2020³⁶.
24. La définition légale du viol n'est pas basée sur la notion de consentement mais sur l'emploi de la force, de la menace ou de la tromperie illégales dans le but d'outrepasser la volonté d'une personne, ce qui signifie qu'un rapport sexuel non consenti qui a lieu sans recours à la menace, à la tromperie ou à la violence n'est pas considéré comme un viol³⁷. Pour la jurisprudence établie, si une victime ne résiste pas physiquement, alors l'acte n'est pas un viol³⁸.

Droits sexuels et reproductifs

25. Depuis le dernier examen, les droits sexuels et reproductifs (DSR) n'ont cessé d'être restreints et ont fait l'objet d'attaques incessantes ; c'est notamment le cas de l'accès à l'avortement, à la contraception et à l'éducation sexuelle complète³⁹.
26. Le 22 octobre 2020, en réponse à une motion des députés du parti au pouvoir, la Cour constitutionnelle a estimé que l'avortement dans des cas de malformations graves ou mortelles du fœtus était inconstitutionnel et devait être interdit. Cette décision limite encore davantage l'accès à l'avortement en Pologne, qui était déjà fortement restreint, et rend illégaux la plupart des avortements dans le pays (plus de 90 % des cas étaient dus à ces motifs)⁴⁰.
27. Cette décision a provoqué une forte réaction sociale et donné lieu à d'énormes manifestations, qui se sont heurtées à la violence policière. De fait, les femmes ayant besoin d'avorter doivent se rendre à l'étranger. Si les statistiques officielles n'ont recensé qu'environ 1000 interruptions de grossesse par an⁴¹, des données issues de la société civile indiquent que plus de 30 000 femmes ont avorté en se rendant à l'étranger ou en se procurant des pilules abortives en dehors du pays⁴². Quatre projets de loi examinés au Parlement restreindraient davantage encore l'accès à l'avortement⁴³.
28. En 2017, le Parlement s'est prononcé pour la fin de la disponibilité et de l'accès sans ordonnance à la contraception d'urgence⁴⁴. Cet événement, ajouté à de nombreuses autres restrictions dans l'accès à la contraception, ainsi qu'au manque d'accès à une éducation complète sur la contraception et la sexualité, constitue une grave violation des droits humains et met la population en danger. Il a également fait de la Pologne le pays européen où l'accès à la contraception est le plus difficile⁴⁵.
29. En avril 2020, un projet de loi criminalisant la fourniture d'informations sur la sexualité à des mineurs (personnes de moins de 18 ans) a été examiné au Parlement et adopté en première lecture⁴⁶.
30. Les défenseur·e·s des droits humains travaillant sur les droits sexuels et reproductifs (DSR) sont harcelés et persécutés à la fois par l'État et par des acteurs non étatiques qui s'opposent à l'existence de services d'avortement sûrs et légaux. En mars 2021, une menace d'attentat à la bombe a été envoyée à de nombreuses ONG œuvrant pour les droits des femmes. Les femmes défenseures des droits humains et les personnes qui défendent les droits liés au genre (FDDH) ont été ciblées par des campagnes de dénigrement très néfastes et stigmatisantes : elles ont été qualifiées de « meurtrières » et leurs visages ont été diffusés publiquement⁴⁷. Des dizaines de militant·e·s font l'objet d'enquêtes voire sont poursuivis pour avoir participé à des manifestations contre la restriction du droit à l'avortement ou pour avoir fourni des informations relatives à cette pratique⁴⁸.

Liberté de réunion pacifique

31. Les manifestations organisées par des opposant·e·s au gouvernement et celles organisées par ses soutiens n'obtiennent pas le même accès à l'espace public, et ne sont pas protégées de la même manière par la police⁴⁹.
32. En juillet 2017, dans plus d'une centaine de villes du pays, des milliers de personnes sont descendues dans la rue pour protester contre la réforme de l'appareil judiciaire. La police a répondu par des mesures de sécurité brutales dans les quartiers du Parlement et du palais présidentiel, ce qui a entravé la capacité des manifestant·e·s à protester à portée de vue et de voix du public visé. La police a arrêté des dizaines de manifestant·e·s pacifiques et a multiplié les formes de surveillance permanente ; elle a notamment contrôlé leur identité au cours de l'événement et les a menacés de poursuites pénales. Après les manifestations, de nombreux manifestant·e·s ont été inculpés pour atteinte à l'ordre public et violation de la loi relative aux rassemblements⁵⁰.
33. Les personnes LGBTI ayant organisé des marches des fiertés ont rencontré des difficultés particulières. En octobre 2021, le Parlement a examiné un projet de loi soumis par l'organisation non gouvernementale « Stop

LGBT », qui a pour but de faire interdire toute forme de « promotion » des relations sexuelles entre personnes de même sexe⁵¹.

34. En mai 2020, pendant la campagne présidentielle, la police a procédé à des centaines d'arrestations de manifestant·e·s pacifiques dont le seul tort avait été de s'exprimer pacifiquement dans la rue. De lourdes amendes ont également été imposées, tout particulièrement aux personnes qui demandaient le respect de l'indépendance du pouvoir judiciaire ou qui dénonçaient le manque de soutien accordé aux petites entreprises pendant le confinement décrété face à la pandémie de COVID-19⁵².
35. En novembre 2020, la décision de la Cour constitutionnelle en vertu de laquelle le recours à l'avortement serait anticonstitutionnel a déclenché d'immenses manifestations. La police a répondu par un recours à la force excessif et inutile contre les manifestant·e·s et les journalistes : elle les a frappés avec des matraques et les a aspergés de gaz poivre. La publication de cette décision, en janvier 2021, a déclenché de nouvelles manifestations. La police a arrêté 20 manifestant·e·s lors des rassemblements qui se sont tenus à Varsovie le 27 janvier et a en outre porté devant la justice 250 affaires concernant des infractions administratives présumées. Les manifestant·e·s interpellés ont été conduits dans des commissariats situés en dehors de Varsovie, ce qui a restreint leurs possibilités de bénéficier des services d'un avocat⁵³.

Liberté d'expression

36. Les personnes considérées comme critiques à l'égard du gouvernement, comme certains juges, procureur·e·s, journalistes, militant·e·s des droits humains (particulièrement les femmes), des personnes LGBTI et écologistes ont été victimes de harcèlement, de poursuites stratégiques contre la mobilisation publique (ou procès-bâillons), de procédures disciplinaires, de calomnie, de campagnes de diffamation et de menaces. La situation est exacerbée par le fait que les autorités ne diligentent pas d'enquêtes sérieuses sur ces faits⁵⁴.
37. En janvier, le tribunal de district de Płock a acquitté trois militantes accusées en 2019 d'« offenses à des croyances religieuses » pour avoir détenu et distribué des affiches et des autocollants représentant la Vierge Marie auréolée des couleurs arc-en-ciel du mouvement LGBTI⁵⁵.
38. En novembre 2021, le tribunal de district de Varsovie a déclaré la journaliste Ewa Siedlecka coupable de diffamation pour des articles écrits en 2019 et l'a condamnée à une amende. Ewa Siedlecka avait révélé les actes de celui qui était alors vice-ministre de la Justice et qui, d'après elle, ciblait les juges s'opposant à des réformes et sapait ainsi l'indépendance de la justice⁵⁶.
39. La chaîne de télévision publique TVP a fait douter de son indépendance après avoir soutenu le discours haineux du parti au pouvoir et fortement critiqué l'opposition et les minorités, essentiellement les migrant·e·s et la communauté LGBTI⁵⁷.

RECOMMANDATIONS À L'ÉTAT SOUMIS À L'EXAMEN

Amnesty International appelle le gouvernement polonais à prendre les mesures suivantes :

Droit international

40. Ratifier la Convention internationale pour la protection de toutes les personnes contre les disparitions forcées.

Indépendance de la justice

41. Mettre fin au harcèlement des juges et des procureur·e·s qui critiquent les réformes de la justice et défendent l'état de droit.

Défenseur·e·s des droits humains

42. Mettre fin au harcèlement des militant·e·s ayant prétendument offensé les croyances religieuses et cesser d'employer cette expression à mauvais escient.
43. Cesser l'instrumentalisation des infractions mineures et des poursuites judiciaires contre les militant·e·s et les manifestant·e·s pacifiques.
44. Diliger sans délai des enquêtes approfondies, indépendantes et impartiales sur les menaces et les agressions subies par les défenseur·e·s des droits humains.

Discrimination

45. Comme recommandé précédemment⁵⁸, modifier le Code pénal pour faire en sorte que les infractions motivées par la discrimination fondée sur l'orientation sexuelle ou l'identité de genre fassent l'objet d'enquêtes et soient poursuivis en tant qu'infractions motivées par la haine.
46. Mettre pleinement en œuvre la Convention d'Istanbul sur la prévention et la lutte contre la violence à l'égard des femmes et la violence domestique, et notamment adopter une législation en matière de viol fondée sur la notion de consentement ainsi que donner une définition de la violence économique.

Droits des femmes

47. Modifier la définition légale du viol dans le Code pénal pour en faire un rapport sexuel non consenti.
48. Modifier la définition actuelle de la violence familiale pour inclure la violence économique.

Droits sexuels et reproductifs

49. Assurer un accès rapide, légal et efficace à un avortement sécurisé ainsi qu'à la contraception à toutes les personnes qui en ont besoin, conformément au droit et aux normes internationaux relatifs aux droits humains. À cette fin, décriminaliser tous les aspects de l'avortement et ne pas pénaliser la fourniture de services et d'informations relatifs à la santé sexuelle et génésique⁵⁹ ainsi que mettre en évidence et supprimer toutes les barrières en la matière.
50. Ne pas pénaliser l'éducation sexuelle complète et faire en sorte qu'elle soit proposée à tous les enfants et adolescent·e·s à la fois au sein de l'école et en dehors, conformément aux normes et au droit internationaux.

Droit d'asile

51. Mettre fin aux renvois forcés illégaux (push-back) et aux expulsions collectives de personnes demandeuses d'asile, migrantes et réfugiées.
52. Garantir l'accès au territoire aux personnes en quête de protection et l'évaluation individuelle de toute demande d'asile.
53. Lever l'interdiction faite aux médias et aux organisations humanitaires ou de la société civile d'accéder à la zone interdite pour apporter leur aide.

Liberté d'expression

54. Mettre fin au harcèlement et aux actes d'intimidation des personnes perçues comme critiques à l'égard des politiques gouvernementales, dont des journalistes, des défenseur·e·s des droits humains, des juges et des procureurs.

55. Dépénaliser la diffamation et veiller à ce qu'elle soit traitée exclusivement au civil.
56. Garantir l'indépendance et la liberté éditoriale des services audiovisuels publics pour permettre l'expression d'une vaste gamme d'opinions.

Liberté de réunion pacifique

57. Veiller à ce que les marches des fiertés ne soient pas arbitrairement interdites et garantir que les personnes LGBTI puissent jouir de leur droit à la liberté de réunion pacifique sans craindre de représailles.
58. Veiller à ce que toutes les manifestations bénéficient du même accès à l'espace public et que tous les manifestants soient protégés par la police de la même manière.
59. Veiller à ce que toute restriction pesant sur les rassemblements publics soit nécessaire et proportionnée à un objectif légitime. La décision d'interdire une manifestation ne doit être prise qu'en dernier recours, après une évaluation approfondie ayant établi qu'aucune mesure moins restrictive ne pourrait permettre d'atteindre l'objectif visé.
60. Former correctement les responsables de l'application des lois au maintien de l'ordre dans le cadre de rassemblements, et notamment les informer sur les normes internationales en matière d'usage de la force.
61. Faire en sorte que les responsables de l'application des lois n'arrêtent pas et ne harcèlent pas les manifestant·e·s simplement pour avoir participé à un rassemblement pacifique.
62. Libérer immédiatement toutes les personnes détenues simplement pour avoir exercé leur droit à la liberté de réunion pacifique et abandonner toutes les poursuites engagées contre elles.

⁴ La Cour de justice de l'Union européenne (CJUE) et la Cour européenne des droits de l'homme (CEDH) ont dénoncé à multiples reprises l'impact des réformes judiciaires. Elles ont estimé que la Cour constitutionnelle et la chambre disciplinaire de la Cour suprême ne respectaient pas les exigences minimales qui garantiraient l'indépendance de la justice. En mai 2021, dans son arrêt rendu dans l'affaire Xero Flor c. Pologne, la CEDH a estimé que l'attitude des pouvoirs législatif et exécutif lors de l'élection de trois juges à la Cour constitutionnelle en 2015 avait constitué une ingérence extérieure illégale. En juillet 2021, dans son arrêt rendu dans l'affaire Reczkowicz c. Pologne, cette même cour a estimé que la chambre disciplinaire n'était pas un tribunal indépendant, car les irrégularités relevées dans la nomination de ses juges en compromettaient gravement la légitimité.
