



# FÉDÉRATION DE RUSSIE. SOMBRE ÉPOQUE POUR LES DROITS HUMAINS

## COMMUNICATION D'AMNESTY INTERNATIONAL POUR LA 44<sup>E</sup> SESSION DU GROUPE DE TRAVAIL SUR L'EPU, 13 NOVEMBRE 2023

### RÉSUMÉ

La présente communication a été préparée pour les besoins du quatrième Examen périodique universel (EPU) de la Fédération de Russie, qui doit se tenir le 13 novembre 2023. Amnesty International y évalue la mise en œuvre des recommandations adressées au pays lors de son précédent EPU, notamment en ce qui concerne la législation contre l'extrémisme et le terrorisme, la violence domestique et la sécurité sociale.

Ce document examine également le cadre national des droits humains, en particulier en ce qui a trait aux récentes modifications de la Constitution, à la criminalisation de la liberté d'expression et à la nouvelle loi sur les organisations de la société civile.

Pour ce qui est de la situation des droits humains sur le terrain, Amnesty International exprime ses préoccupations relatives aux violations des libertés d'expression, d'association, de réunion pacifique, de conscience et de religion, au recours à la torture et à d'autres mauvais traitements et à la persécution des personnes lesbiennes, gays, bisexuelles, transgenres et intersexes (LGBTI). Le document se termine par une série de recommandations à l'intention de Russie qui, si elles étaient mises en œuvre, contribueraient à améliorer la situation des droits humains dans ce pays.



## LE PRÉCÉDENT EXAMEN ET SES SUITES

1. Depuis son dernier examen, en 2018<sup>1</sup>, le bilan de la Russie en matière de liberté d'expression, d'association, de réunion pacifique, de religion et de conviction a continué de s'aggraver, poursuivant la tendance observée depuis son premier examen, en 2009<sup>2</sup>. Les recommandations invitant le pays à résoudre ces problèmes dans la pratique et dans le cadre constitutionnel et législatif n'ont pas été mises en œuvre, même celles que la Russie avait partiellement acceptées<sup>3</sup>. La liberté des médias et l'accès aux informations en ligne ont progressivement été restreints, les personnes en désaccord avec le gouvernement sont persécutées et les militant·e·s et organisations non gouvernementales (ONG) politiques et de défense des droits civiques font face à de sévères représailles<sup>4</sup>.
2. Contrairement à de nombreuses recommandations qui lui ont été faites<sup>5</sup>, la Russie a largement étendu le champ d'application de la législation contre l'extrémisme et le terrorisme, et les sanctions prévues ont été utilisées pour réprimer des opposant·e·s politiques pacifiques, des journalistes d'enquête, des blogueurs et blogueuses, des personnes qui critiquaient le gouvernement et certains groupes religieux pacifiques (voir le § 13 et le chapitre sur la liberté d'expression ci-dessous).
3. Les nombreuses recommandations<sup>6</sup> faites à la Russie d'adopter une loi sur la violence domestique et d'en protéger les victimes n'ont pas été appliquées. Le projet de loi présenté en 2019 pour lutter contre ce problème est toujours au point mort<sup>7</sup>.
4. La Russie a en partie appliqué les recommandations concernant la sécurité sociale<sup>8</sup> en ratifiant partiellement en 2019 la Convention (n° 102) de 1952 de l'Organisation internationale du travail sur la sécurité sociale (norme minimum<sup>9</sup>). Elle a également partiellement mis en œuvre certaines recommandations l'invitant à adopter des mesures pour lutter contre la discrimination envers les femmes<sup>10</sup> : la liste des « métiers interdits » aux femmes a été maintenue, mais réduite de 456 à 100 professions en 2021<sup>11</sup>.
5. Contrevenant à ses obligations en matière de droits humains, la Russie a accepté et appliqué une recommandation contraire aux droits fondamentaux l'invitant à « [c]ontinuer à soutenir la famille traditionnelle et à contribuer aux efforts internationaux de promotion et de préservation des valeurs éthiques et familiales traditionnelles<sup>12</sup> » [traduction non officielle]. Elle a notamment apporté à la Constitution une modification discriminatoire (voir § 7) et s'est appuyée sur les notions de « valeurs traditionnelles » et de « famille traditionnelle » pour ne pas adopter de loi sur la violence domestique, pour museler les demandes de protection des droits des femmes, pour promouvoir des lois et des pratiques homophobes (voir § 15 et 30) et pour tenter de saper les protections internationales des droits relatifs au genre dans les instances internationales comme l'Organisation des Nations unies<sup>13</sup>.
6. La Russie n'a pas mis en œuvre les recommandations acceptées en partie<sup>14</sup> ou dans leur totalité<sup>15</sup> visant à faciliter l'accès des mécanismes internationaux de surveillance des droits de l'homme à certaines zones d'Ukraine (dont la Crimée illégalement occupée) et de Géorgie. Malheureusement, la Fédération a rejeté d'autres recommandations pourtant pertinentes relatives au droit international humanitaire<sup>16</sup>. Elle a ainsi refusé de mettre fin à son occupation illégale de la Crimée. En février 2022, la Russie a envahi l'Ukraine, se rendant responsable d'un crime d'agression<sup>17</sup>. Depuis, le pays a annoncé l'annexion de quatre régions ukrainiennes et tué des milliers de civil·e·s en Ukraine et les forces russes ont commis en toute impunité des crimes de guerre et d'autres atteintes au droit international<sup>18</sup>.

## LE CADRE NATIONAL DE PROTECTION DES DROITS HUMAINS

7. Des modifications de la Constitution adoptées en 2020 établissent que « les décisions des organes interétatiques » contraires à la Constitution ne seront pas « applicables en Fédération de Russie<sup>19</sup> ». Elles mettent encore davantage en péril l'indépendance de la justice, au détriment du droit à un procès équitable<sup>20 21</sup>. Elles ont



par ailleurs redéfini le mariage comme étant « une union entre un homme et une femme<sup>22</sup> » et font ainsi obstacle au mariage entre personnes du même sexe.

8. La Russie a été exclue du Conseil de l'Europe en mars 2022 et a annoncé simultanément qu'elle quittait l'organisation. En juin de la même année, elle a décidé unilatéralement de ne pas appliquer les décisions de la Cour européenne des droits de l'homme<sup>23</sup>. En septembre 2022, elle a cessé d'être partie à la Convention européenne des droits de l'homme<sup>24</sup>. Elle a également décidé de se retirer d'autres conventions du Conseil de l'Europe<sup>25</sup>.
9. Des mesures législatives restreignant de manière injustifiée le droit à la liberté de réunion pacifique ont été renforcées à plusieurs reprises. Les récentes modifications interdisent à certaines catégories de personnes (ressortissant·e·s étrangers, personnes apatrides, personnes désignées comme étant des « agents de l'étranger », etc.) d'organiser des rassemblements. Elles interdisent également les réunions publiques dans de nombreux lieux, notamment près des bâtiments publics et dans l'enceinte d'établissements d'enseignement et de santé, et donnent aux autorités le pouvoir de changer unilatéralement le lieu et la date ou l'horaire de manifestations. Aucune disposition juridique ne prévoit la tenue de manifestations spontanées<sup>26</sup>.
10. La législation nationale contient des dispositions sanctionnant l'exercice du droit à la liberté de réunion pacifique. Selon le Code des infractions administratives, une personne qui organise une manifestation pacifique ou y participe s'expose à une amende sévère ou à 30 jours de prison en raison de lois injustement restrictives, même en cas d'infraction mineure, voire insignifiante<sup>27</sup>. La récidive est quant à elle possible de cinq ans d'incarcération<sup>28</sup>.
11. La loi nationale relative à la liberté d'expression a été remaniée à de nombreuses reprises et, chaque fois, des restrictions injustifiées ou des sanctions plus sévères ont été ajoutées. En 2020, les peines applicables en cas de diffamation ont considérablement augmenté, atteignant les cinq ans de prison<sup>29</sup>. Les autorités russes ont interdit la diffusion de « fausses informations en connaissance de cause » en 2019 et l'ont criminalisée en 2020<sup>30</sup>. En mars 2022, à la suite de l'invasion générale de l'Ukraine, la responsabilité pénale a été introduite pour la « diffusion en toute connaissance de cause de fausses informations sur les forces armées russes », avec une peine pouvant aller jusqu'à 15 ans d'incarcération, tandis que « jeter le discrédit sur les forces armées russes » a été érigé en infraction administrative<sup>31</sup> et pénale<sup>32</sup>, possible de cinq ans de prison.
12. Sur un plan plus positif concernant le droit à la liberté d'expression, certaines infractions relatives à l'« extrémisme » ont été partiellement dé penalisées en 2018<sup>33</sup>. Mais d'autres actes similaires (comme l'« exhibition de symboles extrémistes ») ont été érigés en infractions<sup>34</sup>. Les définitions de ces infractions sont excessivement larges, vagues et susceptibles d'être mal interprétées.
13. Une nouvelle loi sur les « agents de l'étranger » adoptée en 2019 a introduit les notions d'« agent de l'étranger individuel » et d'« agent de l'étranger-ONG non immatriculée<sup>35</sup> ». Avec les nouvelles lois promulguées en 2022<sup>36</sup>, ces changements élargissent la définition du terme « agents de l'étranger », permettent une application arbitraire de la loi et limitent sévèrement le droit à la liberté d'expression et d'association. Les ONG, les médias et les particuliers ciblés arbitrairement par les autorités russes et désignés comme des « agents de l'étranger » ne peuvent pas occuper de postes dans la fonction publique, soutenir de campagnes électorales, enseigner, ni exercer de nombreuses autres activités. Elles doivent communiquer maintes informations aux autorités et toutes leurs publications, quel qu'en soit le sujet, doivent mentionner que l'auteur est un « agent de l'étranger ». Cette loi est très dissuasive pour les défenseur·e·s des droits humains, les militant·e·s, les journalistes et les organisations de la société civile.
14. La loi relative aux « organisations indésirables<sup>37</sup> » est toujours en vigueur et continue de gravement entraver le droit à la liberté d'association. Des modifications apportées au Code pénal en 2021<sup>38</sup> et en 2022<sup>39</sup> ont facilité les poursuites contre des personnes soupçonnées d'avoir coopéré avec de telles organisations et la peine maximale pour cette infraction a été portée à six ans de prison.
15. Une loi homophobe adoptée en 2022 a érigé en infraction administrative<sup>40</sup> « la propagande en faveur de relations et (ou) préférences sexuelles non traditionnelles et du changement de sexe ».



# LA SITUATION DES DROITS HUMAINS SUR LE TERRAIN

16. Depuis le dernier examen de la Russie, et surtout depuis 2021, la situation en matière de droits humains s'est nettement dégradée. La répression contre toute forme de dissidence, en particulier contre les personnes critiquant le gouvernement, contre les défenseur-e-s des droits humains, contre les médias indépendants et contre d'autres composantes de la société civile s'est durcie depuis février 2022 et l'invasion générale de l'Ukraine.

## Liberté d'expression

17. Les autorités russes utilisent la législation contre l'extrémisme et contre le terrorisme ainsi que des chefs d'infraction comme la « haute trahison » pour réprimer celles et ceux qui expriment des opinions discordantes. En 2021, les autorités russes ont arrêté Alexeï Navalny, célèbre militant politique et détracteur du gouvernement, puis l'ont inculpé, ainsi que ses collègues, de nombreux chefs motivés par des considérations politiques allant de la fraude à l'« extrémisme<sup>41</sup> ».

18. Les autorités ont utilisé la loi contre les « fausses nouvelles » pour poursuivre des personnes et des médias qui critiquaient leur gestion de la pandémie de COVID-19<sup>42</sup>. Elles ont profité des nouvelles lois interdisant le fait de « jeter le discrédit sur les forces armées » et de « diffuser des informations fausses en connaissance de cause » les concernant pour réprimer toute critique de la guerre d'agression contre l'Ukraine et des crimes de guerre et autres violations perpétrés par les forces armées russes. Entre le début de la guerre et février 2023, environ 4 500 personnes ont reçu une amende dans le cadre d'une procédure administrative pour avoir exprimé leur opposition à la guerre et plus de 180 autres ont été poursuivies au pénal pour cette même « infraction » ou pour avoir contredit ou contesté une information officielle concernant la guerre<sup>43</sup>. Les personnes travaillant dans le domaine de la culture, les célébrités et les gens ordinaires qui prennent position contre la guerre risquent d'être licenciés pour des motifs politiques, d'être désignés comme des « agents de l'étranger » ou de faire l'objet d'autres formes de persécution<sup>44</sup>. En mars 2023, plus de 250 personnes avaient été arbitrairement désignées comme des « agents de l'étranger », vraisemblablement pour avoir critiqué les autorités ou pour avoir exercé leur travail de journaliste.

19. Des médias indépendants de premier plan se sont vu privés de leur licence<sup>45</sup>, ont été ajoutés à la liste des « agents de l'étranger<sup>46</sup> » ou des « organisations indésirables<sup>47</sup> » ou ont fait l'objet de menaces pour avoir publié des informations critiques envers le gouvernement, notamment concernant la guerre. Les forces de sécurité soumettent régulièrement en toute impunité des professionnel-le-s des médias indépendants à des actes de harcèlement, des arrestations arbitraires et de la torture ou d'autres formes de mauvais traitements, en particulier lorsque ceux-ci couvrent des manifestations<sup>48</sup>.

20. Des personnes qui critiquaient les autorités locales en Tchétchénie ont été arrêtées arbitrairement et soumises à une disparition forcée, en toute impunité. En 2020, le blogueur Salman Tepsourkaïev, modérateur d'une chaîne Telegram critique envers le dirigeant tchétchène Ramzan Kadyrov, a été enlevé chez lui, dans le territoire de Krasnodar, torturé<sup>49</sup> et, d'après ses collègues, tué par des responsables de l'application des lois en Tchétchénie<sup>50</sup>. En 2022, Zarema Moussaïeva, mère du défenseur des droits humains tchétchène Aboubakar Yangoulbaïev, a été arrêtée arbitrairement à Nijni Novgorod par des policiers tchétchènes, emmenée en Tchétchénie et inculpée à tort d'avoir attaqué un de ces agents. Il semblerait que ces poursuites aient été menées en représailles au travail de son fils<sup>51</sup>.

## Liberté d'association et défenseurs des droits humains

21. La loi sur les « agents de l'étranger » et celle sur les « organisations indésirables », souvent appliquées contre les médias, sont utilisées encore plus fréquemment contre les ONG nationales et internationales travaillant en ou sur la Russie, ainsi que contre des groupes informels et des défenseur-e-s des droits humains. En 2021, les autorités russes ont invoqué des infractions à la loi sur les « agents de l'étranger » pour fermer arbitrairement Mémorial, la plus vieille organisation de défense des droits humains du pays<sup>52</sup>. En 2023, elles ont arbitrairement fermé le Groupe Helsinki de Moscou, une autre vieille et célèbre association de défense des droits humains, pour de



prétendues infractions à la loi sur les ONG<sup>53</sup>. De nombreux autres groupes œuvrant en faveur des droits fondamentaux ont été obligés de fermer ou de quitter la Russie sous la pression des autorités.

22. Des groupes politiques d'opposition ont été arbitrairement interdits après avoir été qualifiés d'« extrémistes », comme la Fondation anticorruption (FBK) d'Alexeï Navalny<sup>54</sup>, ou d'« indésirables », comme le mouvement Russie ouverte<sup>55</sup>. D'autres sont visés par des sanctions pénales, soi-disant pour avoir « porté atteinte aux droits des citoyens », comme le mouvement de jeunes Vesna<sup>56</sup>. Dans certains cas, les autorités ont eu recours à la loi contre le terrorisme pour poursuivre des défenseur·e·s des droits humains sur la base de charges forgées de toutes pièces. Bakhrom Khamroïev, par exemple, a été accusé de faire partie du mouvement Hizb ut-Tahrir<sup>57</sup>, un groupe désigné comme « terroriste » par les autorités russes.
23. En 2019, Oïoub Titiev, responsable de l'antenne de Mémorial en Tchétchénie, a été condamné à quatre ans de prison sur des accusations contournées liées aux stupéfiants<sup>58</sup>. Pendant ce temps, des crimes perpétrés contre des militant·e·s pour les droits humains sont restés irrésolus, comme l'homicide de la prédécesseure d'Oïoub Titiev, Svetlana Estemirova, en 2009<sup>59</sup>.

## Liberté de réunion

24. Les autorités russes utilisent d'anciennes et de nouvelles lois pour saper encore davantage le droit à la liberté de réunion. Les mesures de lutte contre la pandémie de COVID-19 servent souvent de prétexte pour interdire des manifestations, alors que les rassemblements progouvernementaux et les événements apolitiques sont autorisés. Les autorités profitent de la procédure de notification pour refuser arbitrairement d'autoriser certains rassemblements publics. Les manifestations pacifiques « non autorisées » sont considérées comme illégales, même lorsqu'il s'agit de piquets de grève solitaires. Elles sont brutalement dispersées par la police et les participant·e·s sont souvent arrêtés et sévèrement sanctionnés par des peines d'incarcération ou des amendes. Les violations des droits humains commises par la police ne donnent pas lieu à des enquêtes et restent non résolues<sup>60</sup>. Plus de 47 000 manifestant·e·s ont été arrêtés entre 2018 et 2022, dont au moins 38 000 ces deux dernières années<sup>61</sup>, notamment grâce à la surveillance de masse et aux technologies de reconnaissance faciale.
25. Les personnes arrêtées se voient généralement infliger d'importantes amendes ou des peines d'incarcération (appelées arrestations administratives). Des manifestant·e·s pacifiques sont poursuivis et condamnés à de longues peines de prison au titre de l'article 212.1 du Code pénal (« violations répétées de la procédure établie pour l'organisation ou la tenue de rassemblements publics ») pour des infractions insignifiantes à cette loi excessivement restrictive, ambiguë et vague ou parce que celle-ci est appliquée de manière arbitraire<sup>62</sup>. Des organes gouvernementaux et des entreprises proches de l'État poursuivent des militant·e·s devant les tribunaux civils, qui leur ordonnent de payer des sommes énormes et injustifiées pour couvrir les préputées « pertes » associées à des rassemblements (comme une baisse temporaire de chiffre d'affaires pour un restaurant, par exemple) ou rembourser les frais de maintien de l'ordre<sup>63</sup>.

## Liberté de religion et de conviction

26. En 2017, la Cour suprême a arbitrairement qualifié les témoins de Jéhovah d'« organisation extrémiste ». Depuis, les autorités ont arrêté arbitrairement des membres de ce mouvement, les ont torturés et soumis à d'autres mauvais traitements et les ont condamnés à de longues peines de prison pour leurs convictions religieuses. Fin 2022, selon les informations dont nous disposons, environ 120 témoins de Jéhovah étaient encore derrière les barreaux<sup>64</sup>.

## Torture et autres mauvais traitements

27. La torture et les autres formes de mauvais traitements demeurent omniprésentes dans les établissements pénitentiaires. Il est courant que des détenu·e·s soient frappés ou humiliés par des membres du personnel pénitentiaire ou des codétenu·e·s (avec l'assentiment du personnel). Les privations de sommeil ou de soins médicaux et les châtiments disciplinaires arbitraires comme l'enfermement prolongé à l'isolement dans des conditions inhumaines sont également fréquents<sup>65</sup>.



28. L'impunité est presque totale pour les actes de torture. Les organes d'application des lois refusent généralement de façon arbitraire d'enquêter sur les allégations de torture. Lorsque des enquêtes officielles sont ouvertes, elles sont injustifiablement lentes. Dans les rares cas où des personnes sont condamnées pour de tels actes, les peines appliquées sont souvent clémentes. Dans une affaire qui a fait la une des médias, un tribunal a condamné, vidéo à l'appui, 12 gardiens de prison de la colonie de redressement n° 1 (IK-1) de Iaroslavl à des peines de prison pour avoir roué de coups Evgueni Makarov, mais le directeur par intérim et son adjoint ont été mis hors de cause<sup>66</sup>.
29. Les extorsions d'« aveux » sous la contrainte sont courantes, surtout dans les affaires liées au « terrorisme » et dans les poursuites pénales contre des manifestant·e·s. Les tribunaux considèrent presque toujours ces « aveux » comme des éléments à charge recevables. Dans les affaires motivées par des considérations politiques, des vidéos des personnes poursuivies s'incriminant elles-mêmes sont parfois diffusées en ligne. Ainsi, en 2022, le poète Artiom Kamardine a été arrêté arbitrairement pour avoir publié un poème pro-ukrainien. Il a été roué de coups et, semble-t-il, violé, puis contraint de « présenter ses excuses » devant une caméra<sup>67</sup>.

### Discriminations contre les personnes LGBTI

30. Les personnes LGBTI continuent d'être la cible d'actes de discrimination et de persécution. Elles se voient notamment infliger de lourdes amendes, sont licenciées de manière discriminatoire et sont victimes de harcèlement. La campagne d'enlèvements et de disparitions forcées, de détention secrète, de torture et, dans certains cas, d'homicides illégaux d'hommes considérés comme gays en Tchétchénie en 2017, dont les médias se sont largement fait l'écho et dont les éléments de preuves ne manquent pas, n'a jamais donné lieu à une enquête officielle et personne n'a été traduit en justice pour ces faits. En 2022, les librairies<sup>68</sup> et les services de diffusion de vidéos en continu<sup>69</sup> ont été contraints de supprimer tous leurs contenus associés aux personnes LGBTI. En revanche, la militante pour les droits des femmes et des personnes LGBTI Ioulia Tsvetkova, poursuivie pour « pornographie », a été mise hors de cause en 2022 après des années de harcèlement.

### Crimes de guerre

31. Amnesty International a recueilli des éléments de preuve solides faisant état de crimes de guerre commis en toute impunité par les forces russes à la suite de l'invasion de l'Ukraine<sup>70</sup>, en particulier le bombardement du théâtre d'art dramatique de Marioupol, connu pour héberger des centaines de civil·e·s<sup>71</sup>.

## RECOMMANDATIONS À L'ÉTAT SOUMIS À L'EXAMEN

Amnesty International engage les autorités russes à :

### Liberté d'expression

32. abroger les articles du Code pénal et du Code des infractions administratives interdisant et sanctionnant le fait de « discréditer les forces armées », de « diffuser de fausses informations en connaissance de cause » et d'autres formes d'expression protégées ;
33. modifier la législation relative à la « lutte contre l'extrémisme », à la « lutte contre le terrorisme » et à la « haute trahison » de manière à éviter les formulations trop larges ou trop vagues qui laissent la porte ouverte à des interprétations abusives. Cesser de les utiliser contre les personnes qui critiquent le gouvernement, innocenter les personnes injustement condamnées à des peines de prison ou des amendes au titre de ces lois, leur octroyer des réparations adéquates et libérer celles qui sont incarcérées ;
34. dé penaliser la diffamation ;



35. mettre fin aux poursuites contre Alexeï Navalny et le libérer immédiatement et sans condition, ainsi que ses collègues et toute autre personne privée de liberté pour le simple fait d'avoir exercé son droit à la liberté d'expression, y compris en critiquant la guerre d'agression menée contre l'Ukraine ;
36. faire en sorte que des enquêtes efficaces, impartiales et transparentes soient menées sur toutes les arrestations arbitraires, les tortures et autres mauvais traitements, les disparitions forcées et les homicides illégaux commis en Tchétchénie et ailleurs et amener les responsables présumés à rendre des comptes dans le cadre de procédures équitables ;

#### **Liberté d'association et défenseurs des droits humains**

37. abroger toutes les dispositions législatives concernant les « agents de l'étranger » et les « organisations indésirables » et cesser de harceler les organisations de la société civile ;
38. mettre fin à la campagne de dissolution, de harcèlement et de persécution des groupes de défense des droits humains et autres organisations de la société civile, réinscrire ceux qui ont été injustement dissous et leur restituer leurs biens saisis ;

#### **Liberté de réunion**

39. abolir les restrictions excessives à la tenue de rassemblements publics mise en place lors de la pandémie de COVID-19 ;
40. mettre la législation régissant les rassemblements publics et les pratiques de maintien de l'ordre concernées en conformité avec les obligations de la Russie en matière de droits humains, en particulier en levant toutes les restrictions injustifiées relatives aux organisateurs et organisatrices de rassemblements publics et au lieu de ces événements, en permettant la tenue de manifestations pacifiques spontanées et en faisant en sorte que les responsables de l'application des lois n'utilisent pas une force injustifiée ou excessive face aux rassemblements publics et qu'ils soient traduits en justice lorsque c'est le cas ;
