### **MEDICAL ACTION**

#### **Ill-health Li Wangyang, prisoner of conscience, China**

(previous actions: 6 July 1998, ASA 17/015/1998; 27 July 2001, ASA 17/025/2001)

**Key words** prisoner of conscience / ill-health / ill-treatment

#### **Amnesty International's concerns**

Li Wangyang, a prisoner of conscience in Chishan Prison in Yanjiang city, Hunan Province, is reportedly seriously ill. Prison authorities have reportedly denied him medical treatment. His sister, Li Wanglin, was sent to a labour camp for three years in July 2001 for publicly supporting her brother in his appeal for compensation for the abuses he had allegedly suffered in prison. Amnesty International has issued appeals on Li Wangyang's behalf in 1998 and 2001 and is renewing its call for action, including for his sister Li Wanglin.

A former labour activist, Li Wangyang has spent 11 years in prison. He is said to be suffering from heart disease, hyperthyroidism, neck and lower back pain and is going blind.

Li Wangyang was sentenced in late 1989 to 13 years' imprisonment for his involvement in the 1989 pro-democracy protests. He was twice released on medical grounds, firstly in 1996, after which he was returned to prison while still receiving medical treatment, and again in June 2002 because of his poor health. He allegedly spent many periods in solitary confinement and suffered several beatings from prison guards while imprisoned for the first time. He was sentenced again in September 2001 to ten years' imprisonment on charges of "incitement to subvert state power", after campaigning for compensation for the ill-treatment he had received in prison while serving the previous term of imprisonment.

#### **Recommended actions & addresses**

Please write letters in English to the authorities below, using professionally-headed paper if you use this in your profession:

- enquiring about the current state of health of Li Wangyang, held in Chishan Prison in Yanjiang city, and urging that he receive all necessary medical care in accordance with the provisions set out in international standards including the Standard Minimum Rules for the Treatment of Prisoners;
- appealing for Li Wangyang's immediate and unconditional release on the grounds that he is imprisoned solely for the peaceful exercise of his right to freedom of expression;
- calling for the immediate and unconditional release of Li Wanglin, on the grounds that she is arbitrarily imprisoned solely for publicly supporting her brother in his appeal for compensation.
