There are grave fears that the 14 above-named asylum-seekers face imminent *refoulement* to Aceh province, Indonesia, where they may be at risk of serious human rights abuses.

They are part of a group of 27 asylum-seekers arrested by the Malaysian authorities in April 1998. Amnesty International has just learned that six of the 27 were *refouled* on 9 September and another seven on 7 October. The organization is currently seeking further information regarding their situation.

The group of 27 were handed over to the Malaysian authorities after seeking protection in the Swiss, French and Brunei diplomatic compounds in the capital, Kuala Lumpur on 10 April. Since then they have been held incommunicado in Bukit Aman federal police headquarters in Kuala Lumpur. They are reported to have been subjected to torture and beatings after arrest and during interrogation.

Despite repeated requests to the Malaysian authorities, the United Nations High Commissioner for Refugees (UNHCR) continues to be denied access to the above-named Acehnese detainees. The UNHCR considers them to be in need of protection as refugees on the grounds that their situation resembles that of another group of 14 Acehnese, who sought refuge in the US embassy and the UNHCR compound in Malaysia on 10 April and 30 March respectively. These 14 are currently being resettled in third countries after having their cases assessed by the UNHCR.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or in your own language:

- urging the authorities to ensure that the 14 above-named Acehnese asylum-seekers are not *refouled* to Indonesia, where they may be at risk of suffering serious human rights abuses;
- urging that they are given full and immediate access to the UNHCR;
- expressing dismay that Acehnese asylum-seekers have been *refouled* to Indonesia after being denied the opportunity to have their asylum claims assessed by UNHCR;
- urging the authorities to allow the UNHCR and other independent observers full and unhindered access to the detention centres for migrants;

- urging the authorities to abide by their obligations under the principle of *non-refoulement*, and to ensure that no person is returned to a country where they may be at risk of serious human rights violations;
- reminding the authorities of Malaysia's commitment to the Universal Declaration of Human Rights, notably Article 5: "No one shall be subjected to torture or cruel, inhuman or degrading treatment".
