Chile - killing and kidnapping charges against General Pinochet dropped. *CNN* reported that Court of Appeals ordered that charges of murders and kidnappings against General Pinochet were dismissed. General Pinochet could still be tried on charges of attempting to cover up these crimes. He

China - condemned prisoners as organ donors. The *New York Times* reported on the case of Mr. Qiu who was executed for fraud. Mr Qiu's brother found that some of his brother's organs had been taken after execution (11 March).

Israel - proposal to legalise torture. The current government may urge the parliament to approve a law allowing the domestic security service to torture those arrested, according to the *Sunday Times*. Mexico - action against human rights abuses in psychiatric institutions. The organisations Mental Disability Rights International and Witness are taking action to pressurise the Mexican government to end human rights abuses in Mexican psychiatric facilities. Tunisia - authorities refused to let Dr Moncef Marzouki leave the country. Dr Moncef Marzouki was prevented by Tunisian authorities from leaving the country to join his family in France and take up a teaching post at a French university. United Kingdom - prison conditions Birmingham deteriorated. USA - execution of man with mental disability halted. The execution of Antonio Richardson, convicted of murder of two sisters, was halted on 6 March.
