Australia - deaths of Aborigines in custody. A new report of the Australian Institute of Criminology, published 10 years after the Royal Commission into Aboriginal deaths in custody reviews changes over the past decade. Iran - UN denounced "cruel executions". The UN Human Rights Commission denounced on 20 April human rights violations in Iran, including "unsatisfactory compliance with international standards in the administration of justice, in particular public and especially cruel executions", the *Boston Globe* reported (20 April).

During the International Mental Health week, organised by the Rwandan Ministry of Health, the WHO and Swiss embassy in Kigali, health professionals pointed out the steady increase in the number of people suffering from mental illnesses since the genocide in 1994 (*Pan African News Agency* on *Reliefweb*, 22 April).

Thailand - media called to follow last moments of death row inmates. The *BBC* reported that the media were invited to follow the last moments of five men before they were executed. Uzbekistan - human rights activist detained in psychiatric hospital. *Human Rights Watch* reported that Elena Urlaeva, a member of the Human Rights Society of Uzbekistan, was involuntarily detained in the main psychiatric hospital in Tashkent.
