**Saudi Arabia** - The *BBC* reported on 13 May that seven Nigerians have been beheaded in Saudi Arabia after being found guilty of armed robbery. Three other Nigerians convicted of involvement in the

bank robbery had their right hands and left feet amputated. Saudi Arabia also executed a Pakistani citizen convicted of drug smuggling, *ABC* reported on 15 May.

Georges Omar Ruggiu, a Belgian journalist with a Rwandan radio station, has pleaded guilty to inciting killings during the 1994 genocide. According to the BBC, Mr Ruggiu's case is the first in which an international court has tried a suspect who is not a citizen of the country in which the alleged crimes were committed (15 May).

**Turkey** - The trials involving doctors active in human rights in Turkey continue: The time-table of hearings is as follows:

23 May 2000: The fourth hearing of the trial launched against Dr. Zeki Uzun will be held at Izmir State Security Court (SSC) at 11.15

6 June 2000: The fourth hearing of the trial launched against Dr. Alp Ayan and Günseli Kaya will be held at Aliaga Penal Court of First Instance at 11.30

13 June 2000: The third hearing of the trial launched against Prof. Dr. Veli Lök will be held at Izmir Penal Court of First Instance No. 2 at 09.30

In addition there is a law suit launched by Prof Sebnem Korur Fincanci against Erol Cakir, Governor of Istanbul, to be held at Istanbul Court of First Instance No.8, 30 May 2000 at 10.15. Mr. Cakir accused Prof Financi of acting in favour of members or adherents of illegal organizations by furnishing reports for them. Prof Financi then initiated a law suit seeking compensation for the insult to her professionalism and the pressure that impeded her work.

**USA**, Illinois - The *Chicago Tribune* reported on 7 May that two years ago, Illinois judges began sending dangerous sex offenders who had finished their prison term to a new therapy centre.
