**USA** - Debate on the death penalty in the USA continues to increase. Please find below a selection of articles on the issue.

Two-thirds of death penalty cases that were appealed from 1973 through 1995 were successful according to a study by Columbia University, reported the *Chicago Tribune*. The main reasons for errors during the trial leading to a death sentence conviction appear to be incompetent defence lawyers and misconduct by prosecutors.

American Medical Association discusses death penalty: Associated Press reported (13 June) that a resolution drafted by the American Association of Public Health Physicians, asking the AMA to recommend a moratorium on executions until current problems with the penalty are resolved, was rejected by AMA Delegates and a watered-down substitute resolution adopted. The amended resolution asked the AMA simply to "support the availability and use of all appropriate medical forensic techniques in the criminal justice system."

## International tribunals & impunity

**Chile** - Thirteen judges voted in favor of revocation of General Pinochet's immunity from prosecution, nine voted against, *CNN* reported on 5 June.

On 1 June Nigeria became the 97th state to have signed the Rome Statute of the International Criminal Court. On Wednesday 7 June Venezuela ratified the Rome Statute, followed by France on 9 June.
