## **Death penalty**

**China - Increase lethal injections**. The Chinese government has said they will increase the use lethal injection and reduce executions by a bullet to the head or heart, the *Independent* and *CNN* reported. "Developed and civilised countries such as US and Japan still have the death penalty, which shows that it is necessary" according to a professor of law in Beijing.

**USA - Florida.** The Florida Supreme Court has struck down a 1998 constitutional amendment on the grounds that the ballot was misleading (as was argued by abolitionists at the time). **USA - Texas.** A federal judge in Texas has quashed the death sentence of Delma Banks Jr., now 40, 20 years after he was convicted for the murder of a 16-year-old boy. The judge ruled Delma Banks Jr. received poor legal representation and ordered a retrial within 120 days (*Reuters*, 31 August) (no link available).

## **International Criminal Tribunal - ratifications & signatures**

On 6 September 2000, Lesotho became the 16th state to ratify the Rome Statute of the ICC. The Marshall Islands and Mexico were the 99th and 100th to sign the ICC Statute. **Mexico - Sentencing environmentalists.** Rodolfo Montiel and Teodoro Garcia, environmentalists and prisoners of conscience adopted by Amnesty International, have been sentenced to, respectively, six years and eight months' and ten years' imprisonment (*CNN*, 28 August). **Norway - 'War children' used in medical experiments.** The *Dagvisen* newspaper reported that the Norwegian pharmaceutical institute and army tested drugs in the post war years on around ten children fostered by German fathers during the Nazi occupation (*AFP*, 4 September) (no link available).

**Palestinian Authority - Human rights abuses West Bank / Gaza.** The Palestinian Authority has imprisoned journalists, human rights defenders, religious figures, professors and government officials, the *Washington Post* reported in an article reviewing Amnesty International's report *Silencing Dissent* (also see 'Amnesty International reports & statements' above). http://washingtonpost.com/wp-dyn/world/mideast/A12425-2000Sep4.html
