International tribunals & impunity

Croatia - death of ICTY witness. Milan Levar, a former Croation soldier during the Bosnian war, was killed by a bomb, the *Washington Post* reported. Milan Levar had been a witness at the ICTY in the Hague, where he had testified on the murder of Croatian Serb civilians in Gospic in 1991 (14 September).

FRY - war crimes sentence. Mexico - possible extradition torture suspect. *CNN* reported that in the 1970s and 1980s Mexico liked to be known as a haven for refugees fleeing dictatorships in Chile and Argentina while at the same time the government was fighting its "dirty war" against guerillas in its own country. Now Mexico is deciding whether to honour an extradition request from Spain regarding Argentinian torture suspect Ricardo Cavallo (*CNN*, 15 September).

USA - **call for tribunal to try Saddam Hussein**. The US government is calling for a war crimes tribunal to try Saddam Hussein and other Iraqi officials for the deaths of at least 100,000 civilians in Iraq and neighbouring countries, the *Associated Press* reported. Charges would include killing up to 100,000 of Iranians and Kurds with chemical weapons (19 September) (no link available).

Brazil - UN visit on torture. U.N. Special Rapporteur on Torture, Nigel Rodley, said "things were worse than I expected", reported the *Washington Post*. Rodley visited police stations and prisons and found that harsh prison conditions, torture and illegal detention are more commonplace than initially expected (13 September).

Burundi - one step closer to peace accord. Three further Tutsi groups have agreed to sign a peace agreement to end the seven-year-war, the BBC reported. Two Hutu groups are the only two groups

Colombia - rehabilitation child soldiers. "Adriana (17) is a veteran of five years service with the Marxist guerillas of the Revolutionary Armed Forces of Colombia (FARC)", the *BBC* reported. She now lives in a secret rehabilitation centre in Bogota for former child soldiers (18 September). http://news.bbc.co.uk/hi/english/world/americas/newsid_930000/930732.stm

Guinea - rape of refugees. Refugees from Sierra Leone and Liberia have been attacked and some of them raped in Guinea. The attacks followed a speech by Guinea president Lansana Conte on 9 September, making a plea to protect the country from rebel attacks from Sierra Leone and Liberia, *Human Rights Watch* reported (13 September). http://www.hrw.org/press/2000/09/quinearefugees.htm

Indonesia (East Timor) - call for food and medical supplies. The evacuation of 400 humanitarian workers has stopped food, medical and other aid to approximately 90,000 refugees. After an international relief organization's clinic closed there is reported to be an acute shortage of medical supplies. Refugees say the promise of food by the Indonesian government has not been fulfilled (*Washington Post*, 11 September).

Kenya - Six convicts killed. Six people on death row in King'ong'o Maximum Security Prison were killed when trying to flee and sustained extremely bad injuries. Two senior doctors examined the bodies and recorded fractured arms, legs, joint and skull fractures (*Daily Nation*, 14 September). http://www.nationaudio.com/News/DailyNation/Today/News/News11.html

Nigeria - Sharia sentence of 180 lashes. A 17-year old girl has been sentenced to 180 lashes by a court in Zamfara state for pre-marital sex. Police in her village reported her to the court when they saw she was pregnant (*BBC*, 14 September).
