-----RECENT AI STATEMENTS & REPORTS

Turkey: Kurdish girls raped and sexually abused in police custody. New evidence has emerged in the case of two Kurdish girls who were raped and sexually abused in police custody in March 1999: although the girls underwent to medical examinations by different doctors, none of the doctors reported signs of violence. However, a later report by the Turkish Medical Association describes symptoms consistent with the girls' testimonies of sexual torture [AI Index: EUR 44/001/99]. Death Penalty: Public Statement: Amnesty International voiced its disappointment at the UN General Assembly's failure to take action on the death penalty: the proposed resolution - co-sponsored by over 70 countries, including the European Union - calling for a world-wide moratorium on executions was not acted upon in the Third Committee of the UN General Assembly in New York. It was decided not to take action at this session of the General Assembly after running into strong opposition by some states -- led by Egypt and Singapore -- who claimed that calls for the abolition of the death penalty world-wide violated the sovereignty of states [AI Index: IOR 40/03/99, 16 November 1999]. Iraq: Amnesty International exposes recent abuses: This report focuses on grave human rights violations in Iraq that are taking place systematically and with total impunity. These violations range from arbitrary arrest and detention, to torture, extrajudicial and judicial executions after unfair trials, "disappearances" and forcible expulsions on the basis of ethnic origin [AI Index: MDE 14/10/99]. -----AFRICA CHARTER ON CHILDREN'S RIGHTS

The African Charter on the Rights and Welfare of the Child of the Organization of African Unity will enter into force on 29 November 1999, 30 days after receipt of the fifteenth instrument of ratification. The following states have deposited instruments of ratification or accession: Angola, Benin, Burkina Faso, Cameroon, Cape Verde, Lesotho, Malawi, Mali, Mauritius, Mozambique, Niger, Senegal, Seychelles, Togo, Uganda, and Zimbabwe. -----DEATH PENALTY NEWS

The Chicago Tribune claims in a new study it has conducted that "Capital punishment in Illinois is a system so riddled with faulty evidence, unscrupulous trial tactics and legal incompetence that justice has been forsaken". Thailand: One woman and two men were executed by machine-gun at Bang Khwaang Maximum Security Prison in Bangkok on 23 November 1999. This brings the number of people executed so far

this year in Thailand to 16, an unprecedented high number in recent years. At least 36 people face imminent execution, having exhausted all appeals against their death sentences. Officials are reported to have said that there are 40 people on death row. Amnesty International fears that more executions have been scheduled. The authorities do not give details of death sentences or scheduled executions. USA: Innocence: 84th person freed from death row: Alfred Rivera walked out from Forsyth County Jail in North Carolina, after being acquitted at his retrial on capital charges. Rivera is the 84th person freed from death row since 1973 after evidence of their innocence emerged. USA: David Junior Brown executed by lethal injection: David Junior Brown (also known as Dawud Abdullah Mohammed), aged 5, was executed on 19 November by lethal injection in the Central Prison of Raleigh, North Carolina after almost 20 years in death row. Brown, an African American, was convicted by an all-white jury in 1980 of the killing of two white people. Successive appeal courts refused his appeals, while consistently acknowledging the faults in his trial. David Junior Brown becomes the 89th person put to death in the USA this year. -----DOCTORS ARRESTED IN TURKEY

The Human Rights Foundation of Turkey has protested about the fate of two doctors recently detained and allegedly beaten by police. Both doctors have worked for the Treatment and Rehabilitation Centre run in Izmir by the foundation. Gynaecologist Dr Zeki Azun was detained in a raid on his private clinic in Izmir on 19_October and held in detention for six days without reason. In an earlier incident, Dr Alp Ayan, who is a psychiatrist, was detained with a group of more than 70_people who had attempted to enter the village of Helvaci to attend the funeral of one of the victims of the massacre at Ankara Central Prison in September. -----ANOTHER MASS GRAVE FOUND IN EAST TIMOR

The Jakarta Post reported on 25 November the finding of more buried bodies in East Timor by an Indonesian forensic team -- some 25 bodies were found including the remains of 3 priests. A member of the Commission for the Investigation of Human Rights Abuses in East Timor told the paper that the remains were recovered from Oeluli beach, Kobalima district, 3 km from the East Timor border. -----MARY ROBINSON VISITS MEXICO

"... I do believe there is a serious problem with the implementation and administration of justice [in Mexico]" Mary Robinson, UN High Commissioner for Human Rights, said on Wednesday 24 November, on the second day of her five day visit to Mexico. "I raised with [President Zedillo] the number of complaints of violation and the lack of a sense of equality before the law, that one set of armed groups acts with impunity in the Chiapas region," she said. Robinson's schedule included meeting in Chiapas with survivors of the Dec. 22, 1997, massacre of 45 indigenous people, mainly women and children, at the hamlet of Acteal. The killings were carried out by a paramilitary group with close links to the security forces [New York Times, 25 November 1999]
