Israeli historian Hagit Lavski has published a book about Bergen Belsen, the concentration camp which survivors turned into a self-governing community following the end of the second world war. Ms Hagit Lavski stated to the *New York Times* (13 December): "The Bergen Belsen story demonstrates that survivors were not only victims [..].
