Amnesty International welcomed the unanimous verdict by an inquest journey that the Guyana police should be held criminally responsible for the death of Mohammed Shafeek, a 47-year-old fish seller. He was allegedly brutally assaulted by police and refused medical attention. An autopsy report revealed fractures to Shafeek's skull, neck, spinal cord and wrists.
