UA 09/04 Torture/ill-treatment/ Unlawful detention

BURUNDI Alexis NIMUBONA alias "Cewusi" (m)

Several others, names not known

Alexis Nimubona is being unlawfully detained in an unofficial detention centre in southern Burundi after being arrested by members of Burundi's main active armed political group, the *Conseil national pour la Défense de la Démocratie – Forces pour la Défense de la Démocratie*, National Council for the Defence of Democracy – Forces for the Defence of Democracy, led by Pierre Nkurunziza and referred to as the CNDD-FDD (Nkurunziza). He is at serious risk of torture or ill-treatment.

CNDD-FDD (Nkurunziza) members have arrested and detained, mostly briefly, scores of people across the country since December 2003. Amnesty International considers them to be at serious risk of ill-treatment as several people detained in this way are known to have been whipped or beaten.

Alexis Nimubona, also known as Cewusi, was arrested by members of the CNDD-FDD (Nkurunziza), on or around 15 December 2003, on suspicion of collaboration with armed robbers. He was held with another man, in an unofficial place of detention in Rumonge, Bururi Province, reported to be a large hole in the ground. On 4 January, local inhabitants reportedly saw the two men being led away in the direction of a CNDD-FDD (Nkurunziza) base in Kimera, Buyengero commune, Bururi province. The other man was reportedly released on 6 January.

BACKGROUND INFORMATION

The CNDD-FDD (Nkurunziza) signed a power-sharing agreement with the Transitional Government of Burundi in October 2003, and is part of the new inclusive government which came into force in late November 2003. The CNDD-FDD (Nkurunziza) is being gradually integrated into the command structure of the current armed forces and under the terms of a ceasefire agreement thousands of fighters are preparing to be integrated into a new national armed forces or to be demobilised. However, as well as taking an active part alongside government armed forces in ongoing fighting with another armed political group, CNDD-FDD (Nkurunziza) members appear to be openly operating a parallel, armed police force; issuing summonses, conducting searches and arrests, and detaining suspects. They are reportedly administering punishment in the form of fines or beatings, sometimes as many as 100 strokes of a stick or other similar object. Most of those arrested appear to be suspected of armed robbery. Scores of arrests have taken place since December 2003.

An unknown number of people are detained across the country in this way, which places them outside any legal protection. Amnesty International has received information on people arrested by the CNDD-FDD (Nkurunziza) in Bujumbura and the provinces of Rural Bujumbura, Cibitoke and Bururi. The CNDD-FDD (Nkurunziza) is operating at least two unofficial detention centres in the northern districts Kamenge (7th avenue, Gikizi guarter) and Kinama (4th avenue, Bururi guarter) districts of Bujumbura.

On 26 December, CNDD-FDD (Nkurunziza) members took four women suspected of witchcraft from their homes in Ndava zone, Cibitoke province to a nearby road, where they were badly beaten on their legs, arms and feet. Two of the women have since been hospitalized, one with a badly broken arm. Three of the women were fined between 2,000 and 10,000 Burundian Francs (roughly equivalent to US\$2 -10).

On 2 January 2004 CNDD-FDD (Nkurunziza) members arrested Alain Niyonkuru and Didace in Bwiza district, in the north of the capital, Bujumbura, on suspicion of involvement in armed robberies. Alain Niyonkuru is

reported to have been severely beaten. They were detained with four others whose identities are not known in the Kamenge cell. Alain Niyonkuru and Didace were released after intervention by a Burundian human rights group, the *Association pour la protection des personnes détenues et des droits humains*, Association for the Protection of Detainees and Human Rights (APRODH) on or around 7 January.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in French or your own language:

- calling for immediate action to protect those Alexis Nimubona, also known as Cewusi, and others held by CNDD-FDD (Nkurunziza), from ill-treatment and other human rights abuses;
- expressing concern that the government appears to condone detention outside the framework of the law, by CNDD-FDD (Nkurunziza) members, and at reports that several people detained by the CNDD-FDD (Nkurunziza) have been badly beaten and fined (please give examples);
- calling on the government to ensure that suspects are arrested only by members of the recognized security forces and detained only in recognized places of detention, to protect suspects from violations of their rights including the rights not to be arbitrarily arrested, ill-treated or unlawfully detained.
