Amnesty International has received reports that on 9 August 1996, Firmat Niyonkenguruka, sentenced to death on 24 June 1996, and five others on death row named above were transferred to a special cell in Mpimba prison in Bujumbura. The separation took place a day after civil servants meeting government ministers on 8 August had demanded the public hanging of prisoners on death row (see original Urgent Action). Sources in Burundi have expressed fears that the separation of these prisoners from other inmates may be a sign of their imminent execution. There are also fears that they may be subjected to torture and other forms of cruel, inhuman or degrading treatment. At least two dozen detainees have been killed in custody since 1995; three of these were shot dead in Mpimba prison.

Neither the six prisoners nor their relatives have been informed of the reasons for separating them from the rest of the prison population with whom they had so far been held. It is unclear whether the separation of these death row prisoners has also been imposed on about 82 others held in other prisons around the country.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in French, Kiswahili or in your own language:

- expressing concern at reports that six prisoners (name them) have been separated from others in Mpimba prison, thus raising fears that they may be executed in the near future or subjected to torture and other forms of cruel, inhuman or degrading treatment;
- asking if prisoners on death row elsewhere in the country have been separated from others in the same way, and requesting to be informed of the identities of those prisoners and the prisons where they are being held;
- seeking assurances that no prisoners will be subjected to execution, torture or other forms of cruel, inhuman or degrading treatment;
- requesting the authorities to allow the prisoners access to visits by legal counsel, their relatives and members of humanitarian and human rights organizations;
- demanding that the Supreme Court respond to appeals on behalf of the prisoners and that the appeals be heard in conditions that conform to international standards of fair trial;
- urging that if the convictions are confirmed by the Supreme Court, it should sentence them to humane punishment, not the death penalty.
