Melchior Bigirimana is now known to have been summarily executed on 5 November 1996 in Bwiza district, Bujumbura. After passing through the Gatumba transit camp on 5 November as he returned from Zaire, he was taken by officials of the United Nations High Commissioner for Refugees (UNHCR) to report to the Chief of Zone at the Rohero district offices, Bujumbura. From there he was taken with nine others to the *Brigade spéciale de recherches* (BSR), Special Investigation Brigade, in Bujumbura. An official of the BSR is reported to have taken the 10 men to Bwiza district in Bujumbura where they were handed over to members of a Tutsi militia. All were summarily executed by strangulation on Bwiza 9th Avenue.

## FURTHER RECOMMENDED ACTION: If possible, send faxes or telegrams (no mail is currently getting through to Burundi) in French or in your own language; please include as many points as you can;

- expressing concern at the summary execution of Melchior Bigirimana, Marc Sindayigaya and Léonidas Ndayishimiye and seven others on 5 November 1996 by members of a Tutsi militia in Bwiza district, Bujumbura;
- expressing particular concern that they are reported to have been handed over to the militia by an member of the BSR;
- urging that the deaths of the 10 men be immediately investigated by a team including United Nations human rights monitors and representatives of the UNHCR in Bujumbura;
- calling for those responsible for these human rights violations to be brought to justice in accordance with international standards of fairness; members of the security forces who are under investigation should be suspended from their posts pending the outcome of the investigations;
- calling on the authorities to take immediate measures to protect all returnees and other unarmed civilians from human rights violations, including extrajudicial executions, "disappearances", arbitrary arrests and torture.
