CAMEROONMaurice Tchambou

Amnesty International has renewed fears for the safety of human rights defender Maurice Tchambou, who has again been placed in incommunicado detention by the security forces of the *brigade anti-gang*.

The *brigade anti-gang*, a joint military and gendarmerie unit deployed since March 1998 to combat a long-standing problem of armed robbery in the north of the country, has been responsible for the extrajudicial execution of several hundred suspected armed robbers (see *Cameroon: Extrajudicial executions in North and Far-North Provinces*, AI Index: AFR 17/16/98, December 1998).

Maurice Tchambou is believed to have been arrested solely because of his association with the non-governmental human rights organization, the *Mouvement pour la défense des droits de l'homme et des libertés* (MDDHL), Movement for the Defence of Human Rights and Liberties, and his activities in defence of human rights. Members of the MDDHL have been threatened and harassed as a result of their investigation and exposure of killings by the *brigade anti-gang*.

Under Cameroon law, Maurice Tchambou should have been referred to a judicial authority, to be either charged or released, within 72 hours of his arrest. Up to now he has not been charged with any offence and the reason for his arrest remains unclear.

BACKGROUND INFORMATION

Maurice Tchambou was arrested on 21 November 1999 by the gendarmerie - the paramilitary police - in Maroua, Far-North Province. Amnesty International became concerned for his safety when he was transferred the same day to the custody of the brigade anti-gang and held incommunicado. He was returned to the custody of the gendarmerie, where he had been allowed to receive visits again, for about a week to 10 days, before his latest transfer to the brigade anti-gang. His return to detention by the brigade anti-gang coincided with a visit to London, United Kingdom, of Abdoulaye Math, the president of the MDDHL, and a colleague, Semdi Soulaye, during the second week of December 1999.

FURTHER RECOMMENDED ACTION: Please send telegrams/E-mails/faxes/express/airmail letters in French, English or your own language:

- expressing concern about reports that Maurice Tchambou, a member of the Mouvement pour la défense des droits de l'homme et des libertés (MDDHL), Movement for the Defence of Human Rights and Liberties, is again being held incommunicado by forces of the brigade anti-gang in Maroua, Far-North Province;
- urging that his safety be guaranteed while in detention and that he be allowed visits from members of his family, a lawyer and a doctor;
- urging his immediate and unconditional release if, as it appears, he has been arrested solely because of his association with the MDDHL and his activities in defence of human rights.
