Amnesty International has learnt of the release of over 100 prisoners arrested in Malabo on 17 December 1992 including those named above. Following intense international pressure at least 36 prisoners were released between 19 and 21 December 1992. The remaining prisoners were released following a presidential amnesty on 29 December 1992.

Accounts by released prisoners suggest that most, if not all, were severely beaten or tortured, some with particular brutality. Among the most seriously ill as a result of the torture are Celestino Bacale, who sustained severe kidney injuries and broken teeth, Arsenio Moro who sustained a perforated eardrum and broken ribs and the two Catholic priests fathers Luis María Ondo Mayé and Pedro Ncogo - the nature or extent of their injuries is not known to the organization. The Equatorial Guinean authorities have so far refused permission for the injured to leave the country for medical treatment despite requests for their urgent evacuation.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes and airmail letters

- welcoming the release of all the detainees arrested on 17 December 1992; - expressing concern at reports that most of them were subjected to beatings or torture and many sustained severe injuries as a result for which they are not known to have received medical treatment;

- expressing concern about the state of health of the ex-detainees, particularly that of fathers Luis María Ondo Mayé and Pedro Ncogo and of Celestino Bacale and Arsenio Moro, and urging that they be immediately allowed to leave the country to seek appropriate medical treatment;

- calling for a public inquiry into these reports and for those responsible for torture to be brought to justice.
